MINUTES

February 18, 2020

This regular meeting of the Connellsville City Council was held this evening at 6:00 PM at City Hall, Connellsville, PA. Attending this meeting was Mayor Lincoln,

Council members Keedy, Karpiak, Tzan and Topper. Also attending was City Clerk Ohler and Solicitor Witt.

PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE: Rev. Matt Goldsberry lead prayer and asked for a moment of silence to remember William Stewart, III who

lost his life this day.

Mayor Lincoln asked Rev. Matt Goldsberry to discuss the Basketball Program that Calvary Assembly of God Church has going on. He also stated maybe City Council

can play a game against them.

Rev. Goldsberry stated for the past three years, Calvary has opened their gym on Thursdays to 20 to 40 teenagers aged 12 years and up to play basketball. He

added they provide food to the kids. Goldsberry stated they provide a safe place for the kids and talk with them about life issues. He added they begin at 6 PM

until 8 PM-8:30 PM. He also suggested a fundraiser for the church to raise money for new basketball equipment is to have Council come.

South Seventh Street, right onto West Crawford Avenue, right onto South Arch Street, left onto West Green Street and continue onto East Green Street, right onto

Sycamore Street, right onto Davidson Avenue, right onto Race Street, left onto West Green Street, right onto South Arch Street, left onto West Crawford Avenue

and left onto South Seventh Street to finish; Pending review and approval of Police Chief and Fire Chief."

Resolution No. 2-3-2020: "To close West Crawford Avenue and side streets as needed, East Crawford Avenue to North Pittsburgh Street to the Memorial on May 25, 2020 for the Memorial Day Parade; Pending review and approval of Police and Fire Chiefs and PennDOT."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 2-4-2020: "To approve the minutes from the January 21, 2020 City Council Meeting."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 2-5-2020: "To waive the Four-Day Resolution Rule to allow for items submitted after the Four-Day Rule to be read at the meeting tonight, such Resolutions will be marked with an asterisk."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

MAYOR LINCOLN:

Mayor Lincoln stated the Police Chief absent from the meeting due to a tragic incident that happened earlier in the day. He added the Chief will be escorting the juvenile back to the City. Mayor Lincoln stated he and City Council extend their thoughts and prayers to William Stewarts family and friends. He asked the residents to allow the family to mourn in peace now. He also added the Police Department did an excellent job today, thanking them, and he is glad the juvenile is safe.

Mayor Lincoln stated that the Police Department has had a few drug busts and have been working hard to keep the drugs off of the City streets. He thanked them and added there was all hands-on deck today.

Police Department Report

Resolution No. 2-6-2020: "To introduce Bill No. 1 of 2020, "AN ORDINANCE OF CONNELLSVILLE CITY, FAYETTE COUNTY, COMMONWEALTH OF PENNSYLVANIA, ELECTING TO AMEND ITS NON-UNIFORM PENSION PLAN ADMINISTERED BY THE PENNSYLVANIA MUNICIPAL RETIREMENT SYSTEM PURSUANT TO ARTICLE IV OF THE PENNSYLVANIA MUNICIPAL RETIREMENT LAW; AGREEING TO BE BOUND BY ALL PROVISIONS OF THE PENNSYLVANIA MUNICIPAL RETIREMENT LAW AS AMENDED AND AS APPLICABLE TO MEMBER MUNICIPALITIES. IT IS HEREBY ORDAINED BY CONNELLSVILLE CITY, FAYETTE COUNTY, AS FOLLOWS."

City Clerk Ohler stated every six to eight years the City is required to redo the ordinance, noting it will stay the same.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 2-7-2020: "Resolution of the City Council of the City of Connellsville, Fayette County, Pennsylvania. Whereas, Section 5 of the Act of January 24, 1966, L.L. 1535, No. 537, known as the "Pennsylvania Sewage Facilities Act", as Amended, and the rules and Regulations of the Pennsylvania Department of Environmental Protection (Department) adopted thereunder, Chapter 71 of Title 25 of the Pennsylvania Code, require the municipality to adopt an Official Sewage Facilities Plan providing for sewage services adequate for prevent contamination of waters of the Commonwealth and/or environmental health hazards for sewage wastes, and to revise said plan whenever it is necessary to determine whether a proposed method of sewage disposal for a new land development conforms to a comprehensive program of pollution control and water quality management;"

Tom Currey added the Municipal Authority approved it and PA Water Company approved it and attached letters for you in the packet. He further added this is a hoop the DEP is making them go through.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 2-8-2020: "To appoint Ryan J Layton as Emergency Management Coordinator for the City of Connellsville."

Mayor Lincoln added Ryan is a Police Officer for Scottdale and could not get off work this evening. He also thanked Jeff Layton for all of his years of service at Emergency Management Coordinator, noting he trained him well.

Councilman Karpiak added this position is not a "do nothing" job and thanked Jeff Layton for all he has done for the City as coordinator.

Jeff Layton added everyone works together, making a good team and getting things done.

Councilman Karpiak added the flood was not a good time, but he does have fond memories of everyone working together.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Topper, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 2-9-2020: "To accept the resignation of Steve Cooper from the Police Civil Service Board effective immediately."
