## UK regulatory framework

Modern Slavery Act (2015)

Art 54 Supply Chains

- (1) A commercial organisation within subsection (2) must prepare a slavery and human trafficking statement for each financial year of the organisation.
- The Modern Slavery Act 2015 (Transparency in Supply Chains) Regulations 2015 UK Statutory Instruments2015 No. 1833 Regulation 2:

"Prescribed amount of total turnover

2. The amount of total turnover prescribed for the purposes of section 54(2)(b) of the 2015 Act is £36 million. "

## UK regulatory framework

Global Resource Initiative – focus on deforestation

Final Recommendations Report March 2020 :... "seven key commodities – beef and leather, cocoa, palm oil, pulp and paper, rubber, soya and timber is part of the global demand for these commodities. Production of these commodities continues to drive forest loss and conversion of natural habitats

 Department for Environment Food and Rural Affairs, (Defra): Due diligence on forest risk commodities – Consultation document August 2020

## Germany - initiatives

Lieferkettengesetz" – supply chain act

This is a government proposal for a draft bill currently being consulted on.

National action plan 2016 (NAP) based on the Un Global Compact commitments:

voluntary implementation of UN objectives

Review in 2019 and 2020 based on NAP:

WTO should also be used to push for the enforcement of standards of sustainability.

### Switzerland - initiatives

 "Konzernverantwortungsinitiative" – responsible business initiative

This aimed at amending the Swiss Federal Constitution by adding a provision making Swiss businesses liable for breaches of sustainability goals within their groups of companies

## Questions for our 5th Annual Conference

- What means sustainability?
  - Create and enforce high environmental standards
  - Improved human interaction
  - protection of human rights
  - · enforcement of labour laws
- Leaving contracts entirely out of the equation and concentrating wholly on regulation might prove unrealistic, turning a blind eye on commercial practices.
- Using contract as a tool for sustainable supply chains bears the risk of 'passing the buck' down the chain
- This would reinforce traditional imbalances in the supply chain which are to be alleviated by the respective legislative initiatives.
