READ BEFORE SIGNING

In consideration for permission to voluntarily participate in tournaments, events and related activities conducted by Jackpot Team Trail, I acknowledge, appreciate and agree that: The risk of injury, disability, death, loss or damage to my property from the activities involved in this event is significant, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury or death does exist; AND, I have been advised by Jackpot Team Trail, and have had the opportunity to seek legal counsel with respect to the legal effect of this document; AND, I KNOWINGLY AND FREELY ASSUME ALL RISKS REFERRED TO ABOVE, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE JACKPOT TEAM TRAIL, THEIR OFFICERS, OFFICIALS, DIRECTORS, EMPLOYEES, OTHER PARTICIPANTS, SPONSORS, ADVERTISERS, THEIR PARENT COMPANIES AND AFFILIATES, AND IF APPLICABLE, OWNERS AND LESSORS OF PROPERTY USED TO CONDUCT THIS EVENT, AND ASSUME FULL RESPONSIBILITY FOR RISKS ARISING FROM MY PARTICIPATION; AND, I willingly agree to comply with the terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the immediate attention of the nearest official; AND I, FOR MYSELF AND ON BEHALF OF MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS RELEASEES, WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH OR DAMAGE TO PERSON OR PROPERTY, WHICH I SUFFER OR WHICH I AM FOUND TO HAVE CAUSED IN WHOLE OR IN PART BY MY NEGLIGENCE OR INTENTIONAL MISCONDUCT, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES, OR OTHERWISE, TO THE FULLEST EXTENT OF THE LAW.
