Greetings Honorable Ambassadors:


I have attached two copies of the referenced Petition which was received by the Office of the President of the United States of America on January 31, 2013. To date and sixty days later, there has not been any correspondence from that office indicating its receipt and acceptance of the document, or that any action was either contemplated or taken. On the contrary, a criminal, who unconstitutionally and unlawfully holds my Office as Governor of New Mexico, was selected and then permitted to be among those traveling with the Vice President to the Vatican in Rome, Italy representing the United States of America to meet and pay respects to Pope Francis. Allowing a treasonous criminal currently holding that office and the private citizenry of the State of New Mexico in bondage under a system of peonage, a form of involuntary servitude creating an enslaved population as a crime against their humanity, demonstrates President Obama's indifference to the United Nations Human Rights Resolution. Furthermore, public appropriated funds from the public treasury collected under threat of punitive action from the enslaved populations supported the treasonous criminality. Such conduct is both immoral and unworthy of a society claiming to be civilized.

Accordingly, it is my sincere prayer and hope you both will use your good offices as ambassadors of your respective nations to cause the foregoing to be brought before Security Council of the United Nations as a matter for it to consider using the evidence contained in the attached document, and that, with or without Security Council interest, your nations take the matter directly to the International Criminal Court of Justice as crimes against the helpless humanity of three supposedly separate and independent populations currently under the armed might, indifferent, and uninhibited political, economic, and judicial control of unconstitutional and unlawful governments within the United States of America.

Thanking you in advance for what help you may be able to provide as we enslaved peoples have little or no political voice in our health, safety, and welfare, little or no economic stake in the expenditure of public funds collected from us under corrupt and immoral processes, and no, not any, competent judicial courts of law available to us as an enslaved people for those purposes; still further, we, as an enslaved people, cannot claim personal ownership of ourselves, cannot claim possession of ourselves, and cannot claim control of our conduct; the United States Government acts as though it owns, possesses, and controls much of those properties under the enslavement processes.

In the name of international justice, please help us.
