

# Oceanway School of Dance & Performing Arts

## Studio Information

Classes must have 10 students enrolled to stay open.

### Polices, Rules and Regulations

#### Registration

There is a non-refundable registration fee of \$40 for all students. If a student drops out temporarily (is absent from class for one month) then their spot will be given to the next available student. Upon returning to dance class a registration fee will be required.

Payment of yearly tuition is accepted upon request.

Private dance lessons are available at the rate of \$30.00 for half hour or \$50.00 per hour.

10% off tuition for siblings for dance classes only.

#### Payment

**All customers are required to be on Auto Pay.** Auto pay for tuition runs the 1<sup>st</sup> of every month. Costume Fees and Recital Fees will all be on the Auto Pay plan and will run on the required due dates (see those sections for the due dates). If the card on file is delinquent a \$15 late fee will apply. You are welcome to pay all fees in advance. We do not accept checks or cash.

Please note to drop or add a class after registration, you must complete the Drop/Add form at the front desk. To stop automatic payments you must fill out a drop form at least **30 days in advance.** Thank You. No refunds if the card is processed before the drop form is received.

If tuition reaches 2 months past due, that student will loose their place in class(es). The student will need to re-register and pay the registration fee of \$35.00. The monthly tuition is calculated based on annual rates and divided into monthly installments. Although some months may have more class times than others the payments will remain the same. Rehearsals at the end of the year are also included in the pay schedule.

## Calendar

Our school year will begin **August 8, 2022** and will end at the June recital. We will only observe the following holidays during this school year. In case of severe weather, emergency *Oceanway School of Dance and Performing Arts* will follow Duval County Public School's closings.

## Recital

Our annual recital will be held in June 2023. Recital information will be posted when a date is finalized.

### **Costume Fee:**

\$90 per costume

### **Recital Fee:**

The recital fee is due by February 8, 2023.

\$90.00 this includes a pair of tights and prop fee.

### **Tickets to the Dance Recital:**

Tickets are sold separately, they are \$15 in advance and \$20 at the door. Service Fees Apply.

## Attendance

There is no credit or refund given for missed classes. Make-up classes must be scheduled **with the front desk**. Due to recital preparations, during the months of April, May and June make-up classes will not be available. Make-up classes are offered for holidays. Make-up classes are only for the current dance year.

## Withdrawals

We have a 30 day withdrawal policy. See the front desk to fill out a drop form.

## Dress Code

**Girls** Hair should be in a bun for ballet classes and pulled back for all other classes!!

- o **Ballet/ Pointe:** Pink tights, black leotard, pink canvas ballet shoes (leather shoes for 3-7 years old) or pointe shoes. Ballet skirts are allowed, no pants or shorts allowed.
- o **Jazz/Hip-Hop/Tap:** Tan tights, solid colored leotard, dance pants and dance shorts are allowed over the tights. Tan Jazz shoes (prefer the ones that do not tie), black hip-hop dance sneakers, tan velcro buckle tap shoes for ages 3-7 and Tan Oxford Tap shoes for leveled tap classes.
- o **Lyrical:** Black leotard, tan footless tights, tan half shoes.
- o **Acro:** Any color leotard, tan tights, no shoes
- o **For all combination classes (Ages 3-7)** the dancers will need to wear a solid colored leotard, pink tights and all shoes required for the style of dance they are taking (see above).
- o **Musical Theater:** Any color leotard, tights, dance pants and tan jazz shoes.

**Boys:** Wear black dance pants, a white t-shirt and black dance shoes that are required for the style of dance.

**NO JEWELRY should be worn for any dance class!!! No gum chewing allowed in dance class! Only water is allowed in the dance studio.**

### **Etiquette:**

Proper dance attire must be worn at all times. Tights should be worn with dance shorts. Leotards are required. No mid drifts please. Please see dress code for more details. Students must display appropriate classroom behavior at all times, even in the waiting areas. If a student is disruptive, they will be asked to wait in the lobby while their parent/guardian is contacted.

### **Miscellaneous:**

Do not leave valuables unattended. We are not held responsible for loss of personal property. Students must arrive to class on time and must be picked up promptly. All students are to be picked up inside the studio. Cell phones will be turned off during class. Please call the front desk if you need to talk to an *Oceanway School of Dance and Performing Art's* student. The number is 838-1340.
