What should people be able to expect?

- Improved quality of life
- Improved health
- Economic well-being
- Making a positive contribution
- Dignity

Facts for Cornwall

- Over the next 25 years, the population of older people aged 65 and above will increase from 107,700 to 177400 (65%)
- Between 2001 and 2021 there will be an 11% increase in the total number of adults with learning disabilities
- Between 2001 and 2021, there will be a 36% increase in the number of adults with learning disabilities aged over 60
- By' 2028, people aged 85+ (the group most likely to need services), will grow from 14,100 (2005) to 28,600 (2028). This is 103% growth an additional 630 very elderly people every year
- Restormel and North Cornwall will have the greatest increase in 85+ population
- By 2028, there could be 7,000 people with dementia living in Cornwall and at least 17,740 aged
 65+ living with depression.
- Ethnic Minorities currently make up just over 1% of Cornwall's population. (England Average -9% South-West - 2.29% (2001)

EFFECT FOR ADULT SOCIAL CARE IF THINGS STAY THE SAME

- 6,600 additional assessments/reviews of older people per annum
- another 18,000 hours of domiciliary care provision per annum
- an additional 2,220 places in residential and nursing home care over next 22 years
- 20 extra LD placements per year for the next 22 years (@ average cost £1,000 per week = £22,880,000)

CORNWALL - A BRIEF DESCRIPTION OF ADULT SOCIAL CARE PROVISION

As at February 2007

- 808 households received 'Intensive Homecare' (over 10 hours & 6+ visits per week)
- 6,927 older people were 'helped to live at home'
- 2,681 adults with physical disability were 'helped to live at home'
- 1,762 people with mental health needs were 'helped to live at home'
- 904 adults with learning disability were 'helped to live at home'
- 2,421 people financially supported in residential or nursing care

As at June 2007

- 792 households received 'Intensive Homecare' (over 10 hours & 6+ visits per week)
- 6,379 older people were 'helped to live at home'
- 2,651 adults with physical disability were 'helped to live at home'
- 1,676 people with mental health needs were 'helped to live at home'
- 867 adults with learning disability were 'helped to live at home'
- 2,423 people financially supported in residential or nursing care

THE CURRENT NATIONAL SITUATION

 Over two thirds of local authorities already only provide services to those at substantial or critical levels of needs

During 2006/7:

- 82% of councils faced significant budget pressures in learning disabilities
- 59% faced budget pressures for older people
- 56% faced budget pressures across all user groups for home care
- (source: ADASS/LGA draft budget survey results 2006/7)

WHAT DOES THIS MEAN LOCALLY?

- We must (and are) supporting the infrastructure of the voluntary and community sector
- Develop links into existing community groups e.g. parish pastoral ministry teams and Age Concern
- Better information
- Maximise people's incomes

PEOPLE DESERVE BETTER

- •People are living longer and they have a right to live fulfilling lives (research shows that a woman on average spends more than 11 years of her old age in poor health)
- •Carers have a right to fulfilment in their own lives and respite from caring

- •The long term care system is complex, unfair and unsustainable needs are going unmet and means testing causes widespread resentment
- •We need a radical rethink of how care is paid for that is fair and sustainable
- •We need to rethink the role of communities in supporting people with disabilities and older people
- •Revisit funding ambition between health and social care set out in Our Health Our Care Our Sav
- This is NOT an issue that will go away

SUSTAINING COMMUNITIES AND PROMOTING INDEPENDENCE

Cornwall Demographics

- · Beautiful, idyllic, remote and isolated:
- last 10 years 21% increase in resident population over 75 7% nationally
- by 2021 over 26% of population will be over 65
- by 2021 50% increase in over 8Ss; 600 every year
- 5.5m visitors increasing population to 60% in peak weeks
- nearly 56,000 carers over 25% older and provide 50 plus hours of care
- over 23% of over 50s live alone
- spend 70% 90% of time at home
- nearly 50% never go our after dark
- 49% experience some form of exclusion

CORNWALL - ACCESS

- Pockets of deprivation, lack of supportive networks:
- •46% of people in dispersed settlements less than 3.000; many less than 250
- •largest town just over 22,000
- •two acute hospitals; travel time up to two hours longer for IOS
- Council wards have highest levels of deprivation in country
- •21% of over 75s live with chronic disease 18% nationally
- •small but higher than average % of suicides amongst older age
- •over 18% of over 50s have no access to transport
- •16% find it hard to access local facilities
- •22% claim Pension Credit

ENGAGING COMMUNITIES

• OLDER PEOPLE ARE ALREADY ENGAGED:

- over 200 groups in Cornwall and IOS
- 39% of over 65's and 32% of over 75s engaged in informal volunteering
- grandparents undertake childcare around £4b a year; average of 6hours a week
- highlight contribution people make to community well being

• Explore strategies for engagement:

- LA community well-being powers to explore and encourage interdependence; Time Banks, co-housing strategies, technology, facilities for people with mental health concerns
- review obstacles for volunteering; support, benefit entitlement, transport

communities need access to services and support to be sustainable spatial planning is key

PROMOTING INDEPENDENCE

Background

- Response to DASC withdrawal in funding
- no assessment, just conversation
- no magic wand; self reliance & independence
- no new service; community resource
- mapping and gapping
- practical, pro active and positive

BUILDING ON WHAT WE KNOW

Partnerships are key

- greater integration in health, care and prevention networks of organisations

Use existing resources

volunteers and communities, - village halls, pubs, sheltered housing, day care, residential care

Early intervention

as little as possible as early as possible

• Little things matter

respecting lifestyle - practical short term support

IMPACT

- Single call line easy to access information
- 264 older people and carers assisted in 6 months
- 263 remain stable and in low/moderate need or less 1 individual referred back
- Regular monitoring; quick referral to DASC/RATS (Rapid Assessment Team Scheme) if decline
- Building up contacts, networks, conversation
- Roll out January 2008: key worker for each DASC area
- All referrals welcome

REAL LIFE - CASE STUDIES OF REAL PEOPLE

- 56 yr old with learning disabilities
- moderate care package
- difficulties reading, self confidence
- grant for washing machine
- Instructions into pictures
- befriender to assist when needed, day service for lunch
- cooks and does own shopping
- 89 yr old, main carer for wife.
 - neighbour died, loss of support plus loss of confidence
 - attendance allowance and pension credit
 - assistance to go to funeral
 - voluntary driver to take him shopping; met by befriender to take him round shops
 - informal carer to sit with wife

OLDER PEOPLE ARE THE SOLUTION

- · Older people often overlooked as part of the sustainable communities agenda
- Promote opportunities for formal contributions to community involvement; volunteering strategies
- Promote independence in community through supportive physical and social environments
- · Highlight value of social interaction

CONCLUSIONS

It was clear that the projected County budgets for Social Care for 2008/09 onwards will not in any way match the demands made upon it. As numbers requiring support through carers and Care Centres for their day to day needs increases year on year, we all need to recognize that funding for this care cannot be met from County budgets and needs to be allocated from Central Government. I'm sure we all know of friends both young and old who are totally reliant on others giving assistance.

We are all duty bound to do what we can to avert this very real problem.

Just to focus our minds, let's be aware that this next will start with a £7.4 million pound deficit. So your participation in any part of the suggested actions below would be wonderful.

ACTION PLAN

Suggested Actions:

A - PETITION / CHRISTMAS CARDS

Send Christmas cards to Right Honorable George Brown, David Cameron and Vincent Cable effectively in the form of a 'petition' – you can add your own message and post the cards to the Prime Minister, 10 Downing Street, Leader of the Conservatives and Acting Leader of the Liberal Democrats for maximum impact. Free pre-printed cards and envelopes are available from both the named people below - (Postage will need to be paid.)

B - PROMOTING INDEPENDENCE PROJECT

C - FAITH GROUPS

Faith Groups were encouraged to share the report and to discuss how best they can assist with ensuring the old are cared for throughout the years to come Light and Life are making plans to organize some 'low mobility' assistance – getting people together who would otherwise be lonely for long periods of time.

D- DAY CARE CENTRE OPEN DAYS

Appeals were made to Day Care Centres to make themselves available for the elderly to be safe and make good use of – however they in turn are concerned as to how they can come close to balancing projected budgets.

E - SUGGESTIONS INVITED

An opportunity for all members of the Penwith communities to voice their opinions on a problem that will not go away and needs collective support and determination if the elderly people are not to suffer unnecessarily.
