ORDINANCE NO. 2022-04

AN ORDINANCE AMENDING VILLAGE CODE

(Chapter 5—Fees, Subchapter 12—Reimbursement Of Costs)

---

BE IT ORDAINED by the President and the Board of Trustees of the Village of Lily Lake, Kane County, Illinois, that the Village Code, as amended, be further amended as follows:

§ 1. Amending Village Code

(a) Chapter 5—Fees, Subchapter 9—Miscellaneous, is amended by moving Section 516 entitled, Dishonored Checks or Drafts, to Chapter 5, Subchapter 12—Reimbursement of Costs, and renumbering it as Section 541.

(b) Chapter 5 is amended by adding the following as Section 542:

§ 542. Action by the Village suspended while any amount remains unpaid

(a) While any amount owed to the Village by any person is due and unpaid, the Village may decline to accept for filing any other application, petition, or request for approval from that person and may suspend its review or decision on any application, petition, or request for approval then pending on file by that person until all amounts owed to the Village are paid in full.

(b) For the purposes of this section—

(i) "person" means any natural person, sole proprietorship, or legal entity, including, without limitation, any corporation, limited liability company or partnership, general or limited partnership, or trust;

(ii) "amount" means any tax, application fee, license fee, fine, payment, or other debt of whatever kind or description, and any cash deposit,

bond, or letter of credit required to be made in connection with any application, petition, or request for approval or relief under any chapter of this Code including, without limitation, Chapters 4 and 20.

(iii) "owed" means any amount required to be paid to the Village under any provision of this Code, or under any order entered by a hearing officer in any administrative enforcement proceeding, or by any court of competent jurisdiction, or for which the Village has made a demand upon such person, regardless of whether such person acknowledges his or her liability to the Village to pay such amount.

(c) For the purposes of this section, related persons or entities (as defined below), will be deemed to be the same. A person is related to another person if he or she is the grandparent, parent, aunt or uncle, spouse, brother or sister, child, niece or nephew, or grandchild of such person or his or her immediate family (spouse and children). There is no distinction between relationships of the full blood and the half blood or relationships created by birth or adoption. An entity is related to a person if any person to whom that person is related (as defined above), directly or indirectly, has an interest as a shareholder, officer or director of any corporation, member or manager of any LLC or partnership, general or limited partner of any general or limited partnership, or trustee or beneficiary of any trust.

## § 2. Repealer

Any ordinance or any provision of any ordinance in conflict with the provisions of this ordinance is, to the extent of such conflict, repealed.


## § 3. Effective Date


