Jaina Moan, executive director of Friends of Gold Butte, discussed the "History of Gold Butte".





Gold Butte is a unique place. It is located on the edge of the Colorado Plateau, at he junction of two major deserts, the Great Basin and the Mojave. This give the area its unique geology and ecosystem.

Gold Butte has has continuous human occupation since paleo Indian times, greater that 12000 years ago. Jaina described the various occupation period up to the present.

The Friends of Gold Butte are working with local congressional representatives and Senator Harry Reid to establish Gold Butte as a National Monument.

## **Petroglyph Patrols**

At our May meeting Lori Hunsaker, BLM archaeologist and Susan Crook of Conserve Southwest Utah (formerly SUNCLF described a new program in conjunction with the BLM's Preserve and Protect initiative. The program is called Petroglyph Patrol and should be of great interest to all DAS members.

The purpose of the program is "to create a pool of engaged citizens dedicated to enhance and protect National Conservation Lands of Southwest Utah. Volunteers for the Petroglyph patrol accomplish this mission by educating the public at high visitation sites and by reporting vandalism and damage to rock art sites".

The initial focus of the Petroglyph Patrols will be Land Hill (Anasazi Ridge).
