1. Ordinance 571 of 2021:

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE TOWN OF BENTON BY ADDING THERETO SECTION 24-35 PERTAINING TO PARKING IN LOST RIVER ESTATES SUBDIVISION, AND OTHERWISE PERTAINING THERETO

BE IT ORDAINED by the Town Council of the Town of Benton, Louisiana, that the Code of Ordinances Chapter 24, Article 2, Section 24-35 of the Town of Benton to read as follows:

Section 24-35. Parking in Lost River Estates

- (a) No motor vehicle or non-motorized vehicle (including without limitation, trucks, and recreation vehicles), boat, trailer, camper, marine craft, machinery, or equipment of any kind may be parked or stored for longer than twelve (12) hours or on a daily basis on any public street of Lost River Estates, unless such vehicle or object is owned or operated by a guest of the adjacent lot owner and such does not extend beyond three (3) days in a thirty (30) day period. Notwithstanding the twelve (12) hour restriction and the guest parking exception, there shall be no overnight parking on any public street of Lost River Estates, Town of Benton, Louisiana.
- (b) No person shall stop, stand or park a motor vehicle or non-motorized vehicle as described herein, except when necessary to avoid conflict with other traffic, or in compliance with the law, or traffic control

device, in any of the following places within Lost River Estates.

- 1. On a sidewalk or in a neutral area between the street and sidewalk.
- 2. In front of a public or private driveway.
- 3. Within an intersection.
- 4. Within 15 feet of a fire hydrant.
- 5. At any place where parking will obscure or obstruct visibility of any traffic control device.
- 6. Within forty (40) feet of any intersection whether signed or not.
- (c) For purposes of this Ordinance, "Public Street" specifically applies to streets owned and maintained

by the Town of Benton within Lost River Estates.

- (d) Any vehicle that is parked in violation of this section shall be subject to the following penalties:
 - 1. For a first offense, a written notice of warning shall be issued.
 - 2. For a second offense within the same calendar year as the first offense, said offense shall be punishable by a fine up to \$100.00.
 - 3. For a third or any subsequent offense within the same calendar year as the prior

offenses; said offense shall be punishable by a fine up to \$200.00.

BE IT FURTHER ORDAINED that if any provision or item of this Ordinance or the application thereof is held invalid, such invalidity shall not affect the other provisions, items or applications of this Ordinance which can be given effect without the invalid provisions, items or applications and to this end the provisions of this Ordinance are hereby declared severable.
