Commissioner District Boundaries**

Commissioner District 1

Those portions of Sections 1, 2, 11 and 12, Township 8 North, Range 6 West W.M. and that portion of Section 35, Township 9 North, Range 6 West W.M. lying within the boundaries of the Town of Cathlamet;

That portion of Section 12, Township 8 North, Range 6 West W.M. described as follows: Beginning at the intersection of the West right of way line of Jacobson Road with the South right of way line of State Route 4; thence in a southerly direction along said right of way line to its intersection with the West right of way line of Columbia Street; thence in a southerly and westerly direction along said right of way line to its intersection with the West right of way line of Jacobson Road; thence North along said right of way line to the point of beginning.

Commissioner District 2

Sections 7 and 18, Township 8 North, Range 4 West W.M.;

Sections 5 through 18, 20 through 24, 26 and 27, Township 8 North, Range 5 West W.M.;

That portion of Section 1, Township 8 North, Range 6 West W.M. lying North of State Route 4;

Section 2, Township 8 North, Range 6 West W.M., excepting therefrom those portions lying within the boundaries of the Town of Cathlamet and lying West of Elochoman Slough.

Section 12, Township 8 North, Range 6 West W.M., excepting therefrom that portion thereof lying within the boundaries of the Town of Cathlamet; also excepting therefrom that portion thereof described as follows: Beginning at the intersection of the West right of way line of Jacobson Road with the South right of way line of State Route 4; thence in a southerly direction along said right of way line to its intersection with the West right of way line of Columbia Street; thence in a southerly and westerly direction along said right of way line to its intersection with the West right of way line of Jacobson Road; thence North along said right of way line to the point of beginning.

That portion of Section 21, Township 9 North, Range 6 West W.M. assessed under tax parcel number 210906-440001.

Section 35, Township 9 North, Range 6 West W.M., excepting therefrom that portion lying within the Town of Cathlamet;

Sections 6, 7, 18, 19, 30, and 31, Township 10 North, Range 4 West W.M.;

Sections 1 through 36, Township 10 North, Range 5 West W.M.;

Sections 1, 2, 3, 10 through 15, 22 through 25, 34, 35, and 36, Township 10 North, Range 6 West W.M.;
