## General Rules & Reminders

- Your dog must have a CDDA competition number before entering the trials. It is advisable to send in your application at least 2 weeks prior to entering any CDDA trial.

- Dogs must be 12 months of age to compete in CDDA sanctioned classes (with the exception of RPT in which dogs must be at least 14 weeks of age).
- Mini division is for dogs measuring 15” and under. A smaller disc must be used for Mini dogs. (please see list of approved discs on page 3 of Premium)

- **Volunteers** – we will try to have enough volunteers to cover all positions, but in the event that we are shorthanded, please indicate on your form if you are willing to volunteer.
- **Freestyle competitors** – our sound system allows any MP3 player to be plugged in, however it doesn't play CD's. Please make arrangements to get your songs to the Trial Coordinator before the trial if you have them on CD.
- Move-ups - Please notify the Trial Coordinator as soon as possible.
- All dogs must be on leash or crated when not competing. Respect other dogs' personal space and please pick up after your dog.
