RE: Letter of Recommendation for Attorney Deborah Silver, For her Work in Our
Election Case against the Delaware County Board of Elections, in Media, PA.,
Case # CV-2020-007523

To whom this may concern:

This letter is to recommend and provide a reference for Attorney Deborah Silver, Esq., relating to the work she performed representing us in the above-referenced election case.

Without hesitation we all write and direct this letter, as our letter of reference and recommendation, to anyone who may seek to hire Deborah Silver as their election attorney in the future. We were all very happy with her work on our case.

Attorney Silver was great with the media also, skillfully handling interviews with the Philadelphia Inquirer and the DELCO Daily Times (some would say these newspapers are left wing biased media).

Our attorney Deborah Silver was outstanding when we were recently guests on a radio show called the Conservative Voice on Friday, January 29, 2021. She pointed out in a few brief minutes all the pertinent facts about our case, and shed light on the way the courts and opposing counsel are trying to get sanctions against attorneys and their clients simply for trying to enforce the law and obtain integrity in our election.

"Our attorney Deborah Silver is a patriot and a rock star, and has also become our dear friend," said Leah Hoopes during the live radio show.

There has been rampant lawlessness in our elections for years and with the help of Deborah Silver we tried to enforce the law. And for that, Judge Capuzzi castigated both us and our lawyer for bringing our valid case to seek sanctions for conduct which clearly violates the law.

During every step of the legal process Deborah Silver fought for us, for integrity in our elections in order that all America not be deprived of its right to a fair, free and transparent election.

Deborah Silver at times stayed up all night to timely file our petitions for sanctions, to intervene and to file a succinct hard hitting reply brief to the 90-page response submitted by the Board of Elections.

Gregory Stenstrom, who stayed up all night as well, said he appreciated Deborah Silver's will and stamina! On December 22, 2020, after reviewing both the Petitions and Memoranda of Law prepared by Deborah Silver, he told her that both of her petitions (to intervene and for sanctions) are "concise, well written, easily understood, and accurate."

Gregory Stenstrom also made the following observations:

"Most importantly, this is the first and only case I am aware of where the issue of standing of a candidate and election observers is supported by your stated case citations. This is the first and only case where spoliation is called out. This petition also avoids the filing time constraints because it is asking for Contempt of Court, and for remedies and sanctions which are appropriate to the Court of Common Pleas, yet reviewable by the PA. Supreme Court and the SCOTUS should it be summarily dismissed."

Gregory Stenstrom concluded his congratulations and praise by saying:

"I am thrilled with the final product, and grateful to everyone for their patience and diligence, and especially Deborah's grace and stamina under pressure."

Need we say more? We will say more.

Gregory Stenstrom opined that the pleadings prepared by Attorney Deborah Silver were well-written, concise, made sense to the average reader, and did not put people to sleep.

Our case was brought against the Board of Elections because they did not comply with a Court Order by Judge Capuzzi allowing observers at all times that the ballots are being resolved, and because the Board of Elections did not comply with the Pennsylvania Election Code which allows observers to be present while ballots are being opened and counted, until such time as all the ballots are fully counted.

In flagrant disregard of both a court order and the Election Code, the Board of Elections kept observers from being present in the rear room where mail-in ballots were being opened and counted for 3 days, from November 3-5, 2020.

When the Board of Elections finally allowed observers in the room where the resolution of the mail-in ballots was taking place, at 11:00 a.m. on November 5, 2020, the observers were only allowed to be present for 5 minutes every 2 hours, whereas Judge Capuzzi's order and the Election Code states that the observers may be present "at all hours" while the ballots are being resolved, opened and counted.

For some unknown reason, Judge Capuzzi threw out our case, finding that the Board of Elections was in full compliance with his order, which we are certain could not be the case.

Judge Capuzzi, wanting to shoot the messenger for bringing a petition to sanction the Board of Elections for their wrongdoing, said that we are "contemptible," have "unclean hands" and that our attorney, Deborah Silver, was "unconscionable" for failing to cite to a November 2020 Supreme Court decision that actually helped us, where the Board of Elections did not themselves cite to this decision in their 90-page response to our valid petitions.

Judge Capuzzi, for some unknown reason, stated in his ruling that our "claims lack a scintilla of legal merit" even though he never held any evidentiary hearing which we requested in the prayer for relief in our petition for sanctions.

Our attorney, Deborah Silver, in her straight forward succinct writing style, clearly laid out the facts and the case law supporting each petition that we filed yet Judge Capuzzi did not refer to anything she said, nor to any case that she cited, choosing instead to throw us out without referring to anything presented in our petitions.

Judge Capuzzi concluded we had no standing to intervene, even though in Michigan, the court allowed a Secretary of State to intervene in an election case long after that case was initiated against the election officials who also violated the election code in that State. Our interests were not protected by the initial petitioner, the Delaware County Republican Executive Committee, who obtained the November 4, 2020 order of Judge Capuzzi in the first place.


For some unknown reason, John McBlain, the attorney for the Delaware County Republican Executive Committee, refused to join our petitions for sanctions and to intervene, and never himself objected to the Board of Elections disobeying Judge Capuzzi's clear order that observers are permitted to be present where ballots were being resolved at all hours of the resolution process.


In conclusion, we recommend attorney Deborah Silver, and now also our friend, for her dedication in courageously fighting to bring integrity to our elections for us and for America.
