Comrade Đomančić, we think the following information is very important to you:

The child was examined and the above written diagnosis was made. During his illness and recovery the boy was in our care at the Institute. The parents spared no effort and since they are both from medical families they tried all possible means and contacted all medical institutions in the country. The boy's father is an expert in computer technology and a honorary member of many medical and scientific institutions in the country and abroad, and he is also a Republic official.

You will see from the documents enclosed within that the boy was treated at our Institute, at the Specialized Clinic of the Military Medical Academy, at the General Hospital "Dr. Fran Bergane" - Nova Gorica, and at the Otorhinolaringologic Clinic of the Medical Faculty of Belgrade.

so far we have been doing everything possible, and we think we have succeeded in maintaining the boy's psycho-physical condition at a satisfactory level.

We are addressing ourselves to you because we appreciate your approach and method of work. We would be very grateful if you could help us with this case and by means of your bioenergy therapy improve the boy's health condition regarding the psychomotoric retardation and the hearing damage diagnosed; the boy still does not speak although he is 5 years old.

As the director of the Institute for Medical Care of Mother and Child of SR Serbia, I appreciate your approach and method of work. Unfortunately, in our country there is neither medical ethic for your kind of work, nor an institution which could verify it. However, my advice to you is to be patient and persevering and the results will speak for you. I believe in your abilities.




