## MAYOR MATTHEWS:

Police Department Report

Matthews noted the Agenda shows to open bids for the Police car but there are no bids.

**Resolution No. 6-7-2013:** "To appoint Cecilia Driscoll to the Connellsville Zoning Board; term to expire the first Monday of 2015."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Karpiak, Geyer, Ritch, Weaver and Mayor Matthews. The majority of the votes being affirmative, the resolution was adopted.

**Resolution No. 6-8-2013:** "To authorize the acquisition of parcels adjacent to or near the Aaron's Building (Parcel ID Numbers 05060432, 05060431, and 05060406) by the City, or its

nominees or assigns, for the sum of \$25,000.00, plus additional transfer, closing, and settlement costs and expenses; to direct the City Solicitor to prepare and review all related documents; to authorize the execution of an agreement of sale, or other similar document, by the City, or its nominees or assigns, upon the approval of such document by the City Solicitor; to authorize the acceptance of deed for such properties by the City, or its nominees or assigns, upon the approval of such documents by the City Solicitor; and to direct the Agyor, the City Clerk, and all other City officials to execute such agreements and to take all appropriate and necessary action in connection therewith."

Matthews explained that at the last Council Meeting, Council approved selling the Aaron's Building. He noted Council had two choices: to sell it and let it get restored or to come up with the money to tear it down. Matthews explained that Council discussed purchasing the acquiring properties because it's cheaper than the work it could cost them if they didn't own them if they needed to tear down the building. "If the sale goes through, the properties will go with building to the buyer" Matthews stated.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Karpiak, Ritch, Geyer, Weaver and Mayor Matthews. The majority of the votes being affirmative, the resolution was adopted.

**Public Works Report** 

Resolution No. 6-13-2013: "To introduce Bill No. 3, Ordinance No. 1500 of 2013:

AN ORDINANCE OF THE CITY OF CONNELLSVILLE FURTHER AMENDING AND RESTATING ORDINANCE NO. 999, ENACTED JULY 10, 1967; ORDINANCE NO. 1110, ENACTED NOVEMBER 12, 1974; ORDINANCE NO. 1214, ENACTED DECEMBER 28, 1981; ORDINANCE NO. 1247, ENACTED OCTOBER 11, 1985; AND ORDINANCE NO. 1457, ENACTED FEBRUARY 13, 2007, THE CITY'S STREET CUTTING AND DIGGING ORDINANCES; EXEMPTING ADJACENT PROPERTY OWNERS FROM THE REQUIREMENT OF OBTAINING A PERMIT TO DIG OR EXCAVATE CITY SIDEWALKS AND GRASSPLOTS AND INCREASING THE PENALTY FOR VIOLATIONS."

Karpiak explained that this ordinance will allow property owner to get to their sidewalks without paying hundreds of dollars and buying insurances. It will be cheaper for the property owners this way. "Now you just have to come in and notify the City of what you are doing" Karpiak explained. He further reminded the Gas and Water Companies they still need to fill out permits and pay.
