6-11.6 That Policy Number 6-11.6 Compensation for Clay (Borrow Pits) shall be amended to state "Compensation for clay from a pit for the purpose of road construction shall be paid as \$1000.00 flat rate fee for the borrow pit, and also, \$1500.00 per acre for the area used in the construction of a borrow pit to obtain clay for an average 12" road-top. The Municipality shall be responsible for the costs of the Borrow Pit. The contractor/engineer is responsible for estimating the acres used for the borrow pit."

Policy No. **99/21:**Ruten

6-11.5 That Policy Number 6-11.5 Compensation for Clay (Landscape Borrow) shall be amended to state "Compensation for clay for the purpose of road construction shall be paid as \$1500.00 per acre for the area used to obtain clay outside of the right of way in the form of a landscape borrow for on an average 12" road-top. The contractor/engineer is responsible for estimating acres used."

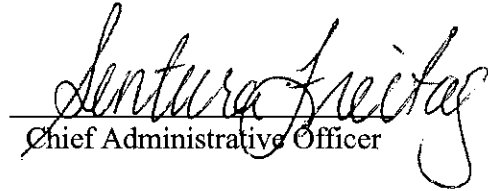
