8. Itemize program operations expenses that you are in need of: i.e., salary, rent, utilities, supplies, equipment, etc.
9. Copy of resume, future/present employees/consultants. Items to include position, salary, commission, etc.
10. Address of location, purchase or lease agreement.

**Remember:** After e-mailing to you this welcome letter and SYLLABUS, it will take approximately 60-90 days to set up your incubator for program implementation and Proposal (Grant) Writing.
