This agreement was made between doodle Best Friends, Teri Casper, referred to as "seller" and \_\_\_\_\_ referred to as "buyer/s" Contract was agreed upon on \_\_\_\_\_. A \$ \_\_\_\_\_ nonrefundable deposit must be made to reserve the puppy of choice. The remaining balance of \$ \_\_\_\_\_ in cash will be due at the time of pick up at 8 weeks old. If for any reason this puppy does not pass an initial veterinarian health check by the seller, then it will be the buyers choice to use the deposit toward another puppy or to receive a refund of their deposit. This puppy will receive all age appropriate shots, de-worming and parasite prevention by 8 weeks old. Buyer has 48 hours after receiving the puppy to have a veterinarian of their choice (preferably with experience of the bulldog breed) to do a health check or health guarantee may be void at the sellers discretion. Buyer agrees that puppy will not be taken to any public areas where other dogs are present or are common to be present until the puppy is fully vaccinated with additional 3 rounds of puppy shots. A puppy can pick up diseases from areas where other dogs have been, even if there are no other dogs present at the time. Any communicable disease is covered through the first vet visit within 48 hours, seller cannot guarantee past that as exposure can show symptoms in as little as 2 days.

If your veterinarian finds any life threatening condition at initial health check, you must contact the seller immediately (that day) with written findings from veterinarian of the problem along with proof of scanned microchip, and please provide vet's contact info. If this occurs, the puppy will be returned to the Seller and a kennel credit for a current or upcoming litter for puppy equal value, if no litters are available within 8 months, a full refund will be given for the initial cost of the puppy. Puppy must be returned in the condition it was received and all paperwork must be returned along with any microchip registration signed back over to the breeder before any refund or exchange is given. If any minor breed related treatable or correctable conditions arise such as cherry eye, entropion, stones, collapse trachea, demodex flare, allergies/skin problems of any kind these are not covered by the Seller. Seller suggests waiting until 1 year old for any cosmetic or spay/neuter surgeries. These are common problems, but are not inherited and some are often due to environment, stress or diet. Hip, elbow, knee dysplasia can be a result of environmental problems such as a lack of proper nutrition, exercise, floor surface, being allowed to jump down or falling off of taller structures or rough housing with other pets or humans. Due to this, Seller cannot guarantee hip, elbow or knee dysplasia beyond the initial health check. Small dogs are very sensitive to low blood sugar, or hypoglycemia which can be life threatening and is due to lack of nutrition. The seller suggests having food available at all times to prevent this issue. Seller has had sought the professional opinion of a licensed veterinarian who provided a health check to ensure the puppy is in the best of health and structure, and has only bred parents without any known health problems. Parents have been health tested for genetic disease and have been cleared of any genetic disorders, as well as had their structure evaluated by a veterinarian or an OFA clinic if available. Any life threatening genetic disorder or disease found that requires treatment, will be either offered a replacement puppy if available, or covered by the seller for up to

the purchase price of the puppy in the cost of vet bills. In the event of death, a full necropsy must be obtained to establish cause of death and veterinarian must determine cause of death with scanned microchip on papers in order to receive a refund or replacement. This guarantee expires one year from the puppy's date of purchase.

**BUYER AGREEMENTS**

If buyer has purchased puppy for pet purposes, the buyer agrees not to allow this puppy to reproduce. Doing so without proper registration would be detrimental to the breed and health of the next generation.

If puppy is found to be in a neglectful state in the care of the buyer, or a caregiver of any kind, the puppy can be immediately seized by the breeder without any kind of monetary exchange. A neglectful state is defined as underweight, injured, untreated medical needs, being used for reproduction .

Buyer agrees that puppy will NOT be resold, given away, transferred to another person of any sort or left at a shelter of rescue. The buyer must contact the seller immediately to transfer puppy back to seller at 1/2 the cost at any point in the dogs life, no matter the condition or health, no questions asked. The buyer agrees to give the seller 3 months to provide payment to take the puppy back.

If any part of this contract is not written in accordance with current city or state laws, the remainder of this contract will be valid and enforceable. Any legal proceedings will take place in the place of sale, Hamilton County Ohio.
