## **ORDINANCE NO.** 5-18 (2009)

## AN ORDINANCE AMENDING THE REGULATIONS FOR PARKING OF VEHICLES ON PINE RIDGE LANE

The Town Board of the Town of Farmington does hereby ordain as follows:

- <u>Section 1</u>. <u>Definitions</u>. "Park or Parking" means the halting of a vehicle, whether occupied or not, except temporarily for the purpose of and while actually engaged in loading or unloading property or passengers.
- **Section 2.** No Parking Where Prohibited by Traffic Signs. No person shall park any vehicle upon any portion of Pine Ridge Lane where parking is prohibited by official traffic signs or pavement markings. Proceeding west on Pine Ridge Lane, parking is prohibited on the left side of Pine Ridge Lane, except for five (5) parking areas near the west end of Pine Ridge Lane.
- **Section 3.** No Nighttime Parking. No person shall park any vehicle upon any portion of Pine Ridge Lane between the hours of 12 midnight and 5:00 a.m.
- **Section 4.** Parking for Vehicles with Trailers Only. Only vehicles attached to a boat trailer shall be permitted to park on Pine Ridge Lane, and then only where parking is specifically permitted.
- **Section 5.** No Parking in Areas Reserved for Physically Disabled. Except for a motor vehicle used by a physically disabled person as defined under §346.503(1), Wisconsin Statutes, no person may park, stop or leave standing any vehicle, whether attended or unattended and whether temporarily or otherwise, upon any portion of Pine Ridge Lane, reserved, by official traffic signs and markings, for vehicles displaying special registration plates used by the Department of Transportation or vehicles registered in another jurisdiction and displaying a registration plate issued by the other jurisdiction which designates the vehicle as a vehicle used by a physically disabled person. Near the water's edge, on the north side of Pine Ridge Lane, two (2) parking areas are reserved for the physically disabled.
- **Section 6.** Penalties. Any person violating this ordinance shall be required to forfeit \$10.00 plus costs. This ordinance shall be enforced through the use of a Town citation. The cash deposit that the alleged violator may make in lieu of a court appearance is \$45.00 which includes the applicable forfeiture, court costs and penalty assessment.
- **Section 7.** This Ordinance shall take effect upon passage and publication according to law.
