An ASCLS Network Story: Greatest Membership Benefit By: Mary Belanus

What does networking have to do with ASCLS? What does networking mean? According to an online business dictionary, two definitions for the word "network" as it relates to computers and communications are:

"Computers: Group of interconnected (via cable and/or wireless) computers and peripherals that is capable of sharing software and hardware resources between many users."

"Communications: Local and long-distance telephone system that connects a caller with the intended receiver via cable and/or wireless through call routing devices called switches."

Now, I want to reword these definitions substituting ASCLS.

"ASCLS: Group of interconnected (via email, telephone, Facebook or snail mail) people that are capable of sharing technical and personal resources between many members."

"ASCLS: Local and longdistance relationships that connect a member with the intended receiver via many mediums for the purpose of communication called network.

These reworded definitions are what ASCLS is all about.

I recently had an opportunity to put my ASCLS network to work for me in my job. As many of you know, I started working for Clinical Laboratory and Standards Institute (CLSI) and my job takes me to Africa. I work with a laboratory in Mali to help prepare them for CAP accreditation and improve their laboratory procedures to provide accurate test results. These results help to support the clinical trials that are being conducted for a malaria vaccine.

The laboratory supervisor, Ag-

niece Guindo was traveling to the United States in December to attend a professional meeting on Infectious Diseases in New Orleans. I started to think: "wouldn't this be a great opportunity for Agniece to see a laboratory in the US." I unfortunately couldn't make it to New Orleans to accompany Agniece on this venture. How was I going to accomplish this task? How was I going to provide Agniece with the experience of a laboratory in the US? I thought of my ASCLS network. I logged on to the ASCLS website and started looking at the leadership roster for the state of Louisiana for a member that may live in New Orleans.

I was instantly connected through the ASCLS network. I called Patsy Jarreau from Louisiana State Health Science Center in the Department of Clinical Laboratory Science. I explained to Patsy that I was an ASCLS member and I pulled her contact information from our website. I explained my position to Patsy and what I wanted to achieve with Agniece's visit to the US. Patsy and I have never met in person. We talked about other ASCLS members that we may know; we talked about the meetings we have attended in the past; we had an instant connection in ASCLS.

Patsy didn't hesitate and she contacted one of her clinical sites to set up the laboratory tour. All of this happened in less than 4 hours of my initial contact with Patsy. I emailed Patsy specific items that I wanted Agniece to see during the tour. Patsy picked Agniece up at her hotel; escorted her to the hospital laboratory; spent two hours with her at the laboratory and then returned Agniece back to her hotel. I called Agniece after the tour and she was so excited. She talked non-stop about what she had experienced and had ideas about implementing changes in her lab back in Mali.

Also, accompanying Agniece was the Principal Investigator from National Institutes of Health (NIH), Dr. Ruth Ellis. When Dr. Ellis found out about the tour, she wanted to tag along. I later received an email from Dr. Ellis, expressing her gratitude for this wonderful opportunity for both her and Agniece.

What a wonderful example of sharing technical and personal resources between members. What a wonderful display of long-distance relationships. What a great way to use the various means of communication available in our network. I tapped into my network to help me accomplish my job.

Patsy provided Agniece with something I couldn't and she didn't hesitate to help another ASCLS member. What I learned from this encounter is that we have a fabulous network in ASCLS. Let's USE our network and PROMOTE our network to others in our profession. I challenge everyone to TALK to their colleagues at work and let them know about our wonderful ASCLS network.

New Administration -

"They" are all saying change is in the air. President Obama was elected on a platform of change. Will anything change for the lab? I suspect plenty will change for all of the U.S. Health Care system.

Looming high on my personal list of injustices in health care, is the disproportionate Medicare reimbursement policy. Why should North Dakota receive lower reimbursement than New York? I've been grousing about that for years! I've hoped that our North Dakota senior senators could make some changes. Gov. Hoeven has some improved changes in his upcoming budget for the next biennium.

Interestingly, former South Dakota senator and senate majority leader, Tom Daschle, will be the new secretary of Health and Human Services in the Obama cabinet. Here's a man who should understand the plight and expense of rural health care. What are his thoughts?

I just ordered my "used -- like new" copy of his book from Amazon.com. [Love that sional health care groups, sent a letter to place! Paid for my plane trip to Europe by selling my used books, but that's another story that has nothing to do with health care.] Its title is Critical: What We Can Do About the Health-Care Crisis.

ASCLS, along with several other profesthe House and Senate Leadership, asking for some of the bailout package money to go toward health professional training programs. I think this is a great idea. If the nation's infrastructure of roads and bridges is going to get help, I think the nation's infrastructure of health care should also benefit.

I think now is the time for health care professionals to educate themselves on what's going on in Washington. I know that even though I've attended Legislative Days and read the ASCLS updates, I don't feel I have all the answers. But with this new administration and all the change that appears to be in the air, I'm taking this opportunity to learn more. It's a new administration with new plans. While I won't be starting on ground floor, I may be starting out on the mezzanine!

November 21, 2008

Item I- Payment of Board meeting meals, lodging and mileage -

Discussion took place and it was determined that this would be a viable expense because of the distances having to be traveled. Motion to include this as a payable expense was made by Elaine R. and seconded by Tori R. All present approved the motion.

Item 2 - Region V Restructuring Task Force / Region V Meeting

Kathy Jones joined the meeting to discuss the proposal from the Region V Restructuring Task Force to hold a Region V educational meeting every year. The meeting would rotate between Fargo, ND (starting in 2011) or Rochester, MN (starting in 2010) and would be started on a 6 year trial basis. This would be 1 ½ day meeting to begin on Thursday with a 5pm keynote speaker and concluding on Friday for a total of ~9 speakers per meeting. The meeting committee would be on a rotating basis so it is possible that even though the meeting was in Fargo, it might be planned, for example, by personnel from South Dakota and Wisconsin.

Kathy stated that they are looking for another ND volunteer – Alice H volunteered.

Region V is looking to develop a logo and key phrase for better signage and visual recognition.

Item 3 – Secretary's report (Alice H / Sue H)

Secretary's report from the April Board Meeting was approved by all present- this was posted in the state newsletter for review

Item 4 – Treasurer's report (Alice H / Sue H)

The treasurer's report was reviewed and approved by all present. A new reimbursement form was presented to better track expenses and to ensure that all receipts are received. Motion to accept the form with the addition of the treasurer's address was made by Stacy A and seconded by Nikki D. All present approved. Form will be made available on the ASCLS-ND web site.

Item 5 - Membership (Mary B)

We are currently at ~90 members. A new source of members might be the new students and faculty of the Rasmussen CLT programs. We also need to look at member retention – Bismarck and Grand Forks areas are doing well, but the Fargo and Minot areas are questionable. With 23 lapsed members in one year, we all need to get on board for this process. Especially worrisome are the members that have lapsed after being very active.

Mary B suggested doing a student meeting in the Fargo area for CLS/CLT students. She will set up a conference call to develop that idea. The Minot and Bismarck areas are interested in participating as well.

Also looking for the existing membership to brain-storm ideas for membership and retention – how do we show the benefit of membership? Send any ideas to the member of the board.

Item 6 - Leadership Development (Stacy A)

Long Term -

- We should be using our existing members to mentor new members possibly an initial letter from am existing member to welcome the new member, with a follow-up at 1,6 and 12 months we will need to pursue this at the state meeting.
- Sharing info about members Elaine and Tori will look at this possibility through the website, however, discussion was held about secure access and confidentiality maybe there could be a more secure access section on the website that was accessible only to members

Short Term -

- 4 Add job descriptions to the website

Also looking at better signage and ASCLS-ND recognition with the development of a new logo – with it possibly being unveiled during the April State Meeting or being voted on during the meeting – possibly in conjunction with a "logo contest"

American Society for Clinical Laboratory Science-North Dakota Proposed Bylaw Amendments

A. Membership in this Society is open to all persons who are members in good standing of the American Society for Clinical Laboratory Science who are residing in or employed in the state of North Dakota, and shall consist of the membership classes as defined by the American Society for Clinical Laboratory Science Bylaws.	Delete residency statement to open membership to ASCLS-ND. There is no ASCLS requirement that restricts membership to any chapter based on residency.	
ARTICLE VII		
Board of Directors		
A. The Board of Directors shall represent the Society when not in business session. The Board of Directors shall consist of the President, President-Elect, Secretary Treasurer, immediate Past-President, two Board members-at-large, the Nominations Chairperson, First Year Professional, and one student representative to be appointed by the President from the students of the host city of the Annual Meeting. New Professional and one student representative who is in their final year of an accredited CLS or CLT program to be appointed by the ASCLS-ND Board of Directors. On the front page under the "quick links" you will find the CE Organizer. This service is offered FREE to all ASCLS members. With the organizer you can add all of your CE credits into it. Then whenever you need a transcript you are able to select the time period that you need the transcript to reflect, and it will print it for you.

In addition, at all national meetings and now gradually at the state meetings, you will find that the P.A.C.E. registration sheets will be missing. That is because at these meetings you will be given a unique code at the end of the session. You then go to the CE Organizer on the web site and enter this code. Once the code is entered, the session will automatically be entered onto your organizer and you will be allowed to print as many copies of your P.A.C.E. form as needed for yourself, employer, etc.

As with any new system there will always be a few bugs to work out along the way. I'm sure that while it will take you just a bit of time to get use to the system, you will greatly appreciate it once it is time to print your transcript for completion of your certification renewal. The P.A.C.E. committee is always willing to work with you on trying to improve the system so that it best serves our members.
