In recalling all the atrocities of 2020, we remember the onset of coronavirus COVID-19, full-time telework, job loss, virtual learning, travel stoppage/bans/cancellations, stimulus payments, unemployment pay in record setting numbers, illnesses, recoveries and sorrowfully, over 400,000 deaths in the US alone. While MISR Court was not immune to the pandemic's wrath, we are grateful for our members impacted who fought and recovered and those who are continuing to recover from the coronavirus' side effects. While life continued, albeit unsteadily, the year 2020 also claimed the lives of three of our beloved members. Below we present to some and re-introduce to others, our 2020 Angelic Lilies - HPC Joyce E. Ellison, PC Geneva E. Rose and HPIC Christine I. Jowers.

HPC Joyce E. Ellison and her young daughter, Jamilah, relocated to the DMV area from Connecticut shortly after completion of her master's degree in Social Work. She had earned her bachelor's degree in Psychology in 1978. Her studies and experience led to a career with DC Public and Charter Schools in various capacities. To continue her faith, she would later join and worship at Alfred Street Baptist Church in Alexandria Virginia quickly becoming a member and sometime lead vocalist on its varied choirs to include Young Adults, Women's, and Adult Choir. She began her Prince Hall journey in the early 1990s attaining membership and ascending to local and Grand leadership in five of the

auxiliaries – OES, HOJ, OGC, LOCOP, and Cyrene. She was created in MISR Court in 2003 and hit the ground running serving on almost all the Court's committees/auxiliaries. She loved the Court, and her proudest attributes were always showcasing MISR in her travels, fundraising for Court programs, the Court Queen, portraying Egyptian Queens/Goddesses or clowning as xxx with the Clown Unit. In honor of her steadfastness to the Court, Joyce was bestowed Honorary Past Commandress during the 2015 Imperial Session. Joyce was a 2nd Degree Blackbelt and occasionally provided self-defense techniques within the Court, Desert, and her church. An accomplished and recorded Alto singer, Joyce was known as "Songbird " to all in the DMV and throughout the Imperial Domain. In addition to her church, Joyce participated in the various choirs of the Masonic auxiliaries. Her talents were frequently called upon to perform solo at many Opening Ceremonies of Conferences, Sessions, Prayer Breakfasts/Luncheons, Christenings/Dedications, Anniversaries and Wake/Funerals of family and friends. A true friend's friend even as her health began to decline. Joyce passed away from cancer of the bile duct on July 6, 2020.



PC Geneva Rose began her Masonic auxiliary journey in 2001 with initiation into the OES and later acquiring membership in HOJ, OGC, LOCOP and Cyrene of which she attained local and Grand officer leadership. She was serving as Most Ancient Matron of her local court at the time of her death. She was created into MISR Court via the Imperial Court's creation during the 2002 Imperial Session in Washington, DC. In MISR Court she served on or Chaired/Co-Chaired many Court committees such as and not limited to Queen, Ways and Means, Egyptian Tea, and Hospitality. Always willing to assist those in need; young, elderly, and disabled, she worked tirelessly on the Court's Community Involvement Committee and further served as an Imperial supporter for the Imperial Court's Margaret P. Warren Ways and Means Committee (2003-2007).

Through her dedicated efforts on the Committee, she was awarded Honorary Past Commandress Degree honors in 2007 and subsequently appointed Deputy Imperial Directress for the Margaret P. Warren Ways and Means in 2008. HPC Rose ascended to Actual Illustrious Commandress of MISR Court in 2009 continuing to share her many talents of old-fashioned hospitality, event planning, floral arrangement, and design in creating beautiful centerpieces as well as creating boutonnieres and corsages for Nobles and Daughters to wear while attending MISR's Joint Ball or representing MISR when traveling to attend Daughter, Noble or Joint affairs within the Desert of Maryland or throughout the Imperial Domain. An avid supporter of the youth, PC Rose served as Directress, DIMES for many years and continued to assist with the "babies" whenever needed until COVID-19 restrictions and her subsequent health began to decline. PC Rose was a skilled dancer and could always be found on the dance floor dancing, hand dancing or teaching someone the latest line dance or MISR stroll. With a diagnosis of pancreatic cancer following a brief hospitalization, PC Rose succumbed to the disease on July 7, 2020.



HPIC Christine Ivey Jowers hailed from Asheville, NC and made



the DMV her home in 1965 upon completion of her degrees in Education. As an educator in Prince Georges County, MD she taught English and Math for many years and through her dedication, ascended to Assistant Principal. She retired in 1993. HPIC Jowers was initiated into the OES in 1982 serving on various committees in the chapter evolving to Worthy Matron in 1999. HPIC Jowers was created in 1982 a charter member of MISR Court. Her dedication and steadfastness elected her to Illustrious Commandress in 1986. She would later serve as the Illustrious Treasurer (2003-2016). An excellent orator and fitting example of finer womanhood, HPIC Jowers was appointed Imperial Deputy for the Desert of Maryland in 1995 and would later receive a political appointment to the PG County Board of Appeals in the same year. She continued to serve the Desert as its Desert Treasurer (2007-2012). The oldest of 8, HPIC Jowers loved spending time with her immediate and extended family and friends. Though she had no biological children, she doted on her nieces, nephews, goddaughters and "adopted" Daughters. HPIC Jowers also loved to travel with the Court and was known to cruise to various destinations at least twice a year for her personal travel. Prior to COVID-19 restrictions and her declining health, HPIC Jowers remained a faithful

and steadfast member of the Court and her OES chapter. HPIC Jowers epitomized a life well lived and always offered engaging conversations and wise counsel when sought. Diagnosed with pancreatic cancer in 2019, HPIC Jowers and her sister Lucille, would both pass away from the disease one day a part in December 2020.

May they all continue to rest in the arms of Allah.



### WOMENS VETERAN TEAM

#### **African American Women Veterans**

#### WHO PAVED THE WAY WORLD WAR I (1914-1918)

African American women have played a role in every war effort in United States history. They endured physical discomfort and personal criticism, while many of their contributions were unrecognized and unrewarded. They placed themselves in danger's path – offering their abilities and strengths to preserve values and ensure freedom. Women stood side by side with fathers, husbands, and sons to nurse and comfort the suffering; they engaged in the danger of spying, chronicled the pain of war, and offered spiritual healing. In addition, black women faced racial and gender discrimination as part of their military service. Nevertheless, there were a number of "breakthrough" moments as they persistently pursued their right to serve (www.nambw.org).

These pioneering women simultaneously mastered the art of building and sustaining family and community life while dealing with wars. They were practiced folk healers, seamstresses,

skilled quilters knowledgeable parents, gardeners, cooks, and kept a storehouse of history and communal information. They knew how to press their skills into service or others. Throughout history, their networking, institution-building skills, and commitment to caring and sharing in health care and educational efforts, campaigns to support the troops, and protests against many forms of discrimination (Lemke-Santangelo, 2003).



Phillis Wheatly Was a very literate Black woman, used her writing ability to praise and express appreciation for General George Washington during the Revolutionary War. He showed his appreciation by inviting her to visit him at his headquarters in February of 1776.

For the first time in military history, African American females had an official organization where they found leadership and direction to use their abilities. The National Association of Colored Graduate Nurses was founded in 1909. In 1917, the co-founder of the Red Cross urged black nurses to enroll in the American Red Cross, although they were not accepted until two months before the war ended in November 1918. African American females continued to serve by making bandages, taking over jobs that men held so they could be soldiers, working in hospitals and troop centers, and serving in other relief organizations as they had in previous wars. Many served in Hostess Houses operated by the Young Women's Christian Association, where they wrote letters home for illiterate soldiers and read incoming mail to them.

As the war escalated, public pressure increased to enlist black women. Eighteen black, Red Cross nurses were offered Army Nurse Corps assignments at Camp Grant, Illinois and Camp Sherman, Ohio. They cared for

German prisoners of war and black soldiers. By August 1919, all black nurses were released from service. One of the nurses, Aileen Cole Stewart, wrote:

"The story of the Negro nurse in World War I is not

spectacular. We arrived after Armistice was signed which alone was anticlimactic. So, we had no opportunity for "service above and beyond the call of duty." But each one of us...did contribute quietly and with dignity to the idea that justice demands professional equity for all qualified nurses."



After World War I, the demand for a permanent place for black women nurses in the military nursing corps continued. Colonel C.R. Darnell, Executive Officer for the Army Medical Corps wrote:

"The question of opening the nurse corps to...colored nurses has from time to time received the serious consideration of this office; but because of the necessity of arranging their tours of duty in various regions of the United States as well as in our overseas dependencies and of the difficulty if not impossibility of arranging proper quarters and messing facilities for them their employment has been found impractical in times of peace. You may rest assured that when military considerations make it practicable...to utilize colored nurses they will not be overlooked."

Black women served in other capacities, as well. Four black women were among the 3,480 "Y" women volunteers who helped soldiers and sailors overseas. The YMCA provided recreation for the American Expeditionary Forces by staffing canteens, nursing, sewing, baking, and providing amusement and educational activities for the soldiers (womensmemorial, 2010).

#### Advances Medical Research for Minority Veterans

The Department of Veterans Affairs (VA) launched a new genomic research tool designed to help VA researchers learn more about how conditions such as cancer, diabetes and heart disease affect Veterans from minority backgrounds.


Debuting in January, the laboratory tool, known as the Ethnic Focused genotyping array or DNA chip, will test more than 750,000 genetic variants, including over 300,000 that are more common in minority populations.

The probes also associate certain health traits — like increased risk for a disease or unfavorable reactions to a drug with specific genetic patterns. This can lead to new treatment approaches for patients with those gene profiles.

With more than 830,000 Veteran volunteers currently enrolled, this is the largest health and genetic databases in the world and has generated dozens of influential scientific publications. Currently, over 30 ongoing studies are examining conditions ranging from heart disease and diabetes to post-traumatic stress disorder, schizophrenia and suicide risk. MVP has been successful in engaging Veterans from minority communities in part thanks to VA's Center for Minority Veterans. The two plan to collaborate this year and beyond, to further boost the involvement of Black, Hispanic and other minority Veterans in the landmark genomic research program.

MISR Court delivered nearly 400 Valentine's Day cards to Veterans at Charlotte Hall Veterans Home. At good leader will think they have all of these traits. A great leader will know that that is impossible.


