

I wanted to use this letter to give an update on our discussion meetings concerning disaffiliation from the United Methodist Church. We have been watching a series of videos produced by Rob Renfroe on why your church should join the Global Methodist Church and the counter point series of videos produced by Adam Hamilton on why churches should stay in the UMC. Both series of videos are really well produced and present good arguments. If you have not had an opportunity to watch them I would encourage you to do so. Just go to YouTube and search Rob Renfroe and they will come up.

In our meetings we watch two videos each week and then have a discussion around what has been presented. My job then is to fill in the gaps or provide insight and more information about what is being presented. I do not know about the denomination as a whole but I do know about our Iowa Annual Conference and share my experiences as clergy. Here are some of the points I brought up and the motivation behind why I scheduled these meetings.

The initial reason that brought about disaffiliation is in regards to differing views on sexuality and the practice of ordaining and affirming practicing homosexual clergy. That is not the only area in which there are differences and that is what these videos point out. In the last few years there has been a lack of transparency in the UMC along with a lack of leadership. In the UMC there is a set of rules and order called The Book of Discipline. Bishops, District Superintendents and clergy who do not agree with what the BOD says have chosen to ignore it and are encouraging others to do so. There is no repercussion, no accountability and when clergy are ordained they make a vow at their annual conference to teach, affirm, and uphold the Book of Discipline. If we have rules and order, then we should follow them.

Second, is we disagree on how we interpret Scripture and the authority of the bible. Our newly appointed bishop Kennetha Bingham-Tsai said in an interview panel that she did not believe everyone should agree on who Jesus is. Also, that Jesus became incarnate but not in "any particular flesh, not in any particular culture." This goes against the traditional understanding that Jesus was a Jewish male in 1st century Israel and downplays his humanity. There was no follow-up question to her answer and was approved as a candidate for bishop from the Indiana Conference and was the first bishop elected just a couple of months ago.

This is only some of what we discussed but you can see it is much more than our differing views on human sexuality because that subject has been argued about at every General Conference since 1972. There is one more set of discussion meetings scheduled and it is specific to each church – Asbury on March 1st and Northwood on March 2nd. Both meetings will take place at 6:30pm. I strongly encourage you to attend this meeting and while I do not anticipate this to be our last meeting on the subject it will give a good indication of where each church is heading and how we are going to proceed in the weeks to come. Be in prayer for our churches, for our leaders, for yourself in this discernment process and I will also ask for all the prayers I can get.

This is not a decision to take lightly, and I want to inform as many people as possible so they can make their own decision.

May God continue to guide and lead us as we do the work and ministry of the church. 

#### 2023 DISASTER RESPONSE: TURKEY-SYRIA

A 7.8 magnitude earthquake struck southern Turkey at 4:17 a.m. on Monday, Feb. 6, 2023, the most powerful earthquake recorded since 1939. In the hours that followed, at least 78 aftershocks were reported, followed by a second earthquake of 7.5 magnitude. More than 5,000 people were killed, with deaths expected to rise.

The earthquake also heavily impacted northwest Syria, where 4.1 million people depend on humanitarian assistance. The majority are women and children. At this time, Syrian communities are simultaneously facing an ongoing cholera outbreak and extreme winter weather events, including



heavy rain and snow. The humanitarian response is overstretched due to the devastation and cold weather.

UMCOR has released an initial solidarity grant to a longstanding humanitarian partner, International Blue Crescent (IBC), which has offices in Turkey. The grant will provide tents, heaters, blankets, warm clothes, ready to eat meals and basic first aid kits. #### El Porvenir: Clean Water, Healthy Nicaraguans [Advance #525000]

Nicaragua is the third poorest country in the Western hemisphere; 80% of the population lives in poverty, surviving on less than \$2 a day. 54% of rural Nicaraguans lack access to clean drinking water; 31% of rural Nicaraguans lack adequate sanitation facilities. Our project provides tangible solutions to communities who are committed to improving their access to clean water, sanitation facilities and better health, but lack the resources to do so. El Porvenir provides the materials which must be purchased and training for the

villagers to enable them to construct the project and undertake its long-term care and maintenance. All water well projects use appropriate, simple technology made in Nicaragua: The primary goal of this project is to push for higher access to clean, plentiful water in the six regions of rural Nicaragua where we operate so communities can thrive.

### Asbury United Methodist Church Administrative Council Minutes

(Unapproved) Wednesday, January 18, 2023 5 pm

Chairperson David Taft called the meeting to order at 5:11pm. Members present were Dave Imler, Daryl Sherman, Brad Grotewold, Rusty Schipper, Dan Tiedman, Aaron Mannes, Wayne Mannes, Scott Nelson, Joyce Sherman, David Taft, Donna Lair, Pastor Rob, and Jill Nelson. Opening was singing Happy Birthday to Joyce.

Secretary's Report was given by Donna. Correction to minutes: The \$93,000 quote from Aaron Mannes was a computer estimator app and not am actual bid by Aaron or Mannes Construction. Motion by Joyce and second from Dan to accept the corrected minutes. Approved.

Treasurer's Report was given by Daryl. 2022 Report was given first. \$24,810.21 was the beginning of the year balance. Ending balance was \$28,077.71. The Parsonage Renovation Fund shows a transfer of \$5,000 from the Trustees to pay for tree removal. There is a separate Parsonage Fund that money is put into by the church for a pastor home. All bills, apportionments, and District Asking's were paid. Report for current year of 2023 shows a beginning balance of \$30,046,03. Dave moved to accept, with Jill second. Motion carried.

Old Business -A new computer was bought for the sanctuary and the old computer was given to Daryl for Treasurer's use. Both computers are working for the uses needed.

**New Business** 

\*Insurance discussion. Daryl passed a handout to explain the insurance increase. Insurance is for church, parsonage property and liability. Insurance is due now. Brad moved to pay the bill; Dave seconded. Motion passes.

\*Recycling discussion. The bill is quite high because we are considered a business. Discussion about stopping the service and how we could handle recycling. It was suggested that people serving fellowship to take it home and add to their home recycling. November is the only month where there is a lot of recycling to church activities. Committees will split up how and where it will go. Joyce moved to stop service with Dan second. Motion was passed.

\*Sound system. There have been some complaints of not being to hear during services. Do we need new speakers? No one has talked to Brad about it. There are things that he can do to clarify the sound besides making it louder or softer. If there are problems, they need to be given to him. We will see if this makes it better.

\*Committee Chairs. Now that covid has/is subsiding, we would like to get back to having committee chairs or a representative at Ad. Co, meetings. Joyce will reach out to committees to see who the chairpersons are. They will be put onto the email list for reminders for Ad. Co. meetings.

\*.Church Steeple. Brad stated that now that the trees are gone that our steeple can be seen from the countryside coming into town from the west. Is there a way to light the steeple at night? There is also some work that needs to be done on the screening on the steeple. It needs to be done from the inside. Dave will take to the Trustees and request a walk around of the building.

\*Parsonage Update. Dave gave the report. Siding and vents have been repaired and glass has been fixed as per the notice from the city. A rental agreement has been drawn up by Ricard Schwarm and has been signed by Casino management. 10% down payment for the roof has been paid. Doors, changing all light bulbs and painting is being done by the Trustees. Young's Plumbing and Heating is making sure all plumbing and heating is working properly or is replaced/repaired. All residents will be male with 4 being maintenance and 8 in the culinary field. The Casino would like to be able to be in March 1 so they can get it furnished. Dave will be checking with the city to see what else may need to be done.

Pastor's Report- Pastor Rob presented the council with handouts comparing UMC to Global Methodist Church. Handouts were prepared by Nancy Mathahs from Northwood. Motion passed. Dave I will contact Young Construction and Young Plumbing and Heating to stall their part of the improvements.

\*Disaffiliation: If we are interested in leaving the UMC, we need to have a letter to the conference by June 30, 2023, to start the process. Conference will get back to us with what is required by August 15, 2023. The vote needs to be August 16-September 30, 2023. David T stated that we need to go through the process so that the congregation has a say in the decision. Asbury meeting on March 1. Pastor Rob will explain our choices. We will decide what is needed to be done from that point. The videos will be shown after church services in the Fireside Room for anyone that would like to see them starting February 19. Daryl and Joyce Sherman will be responsible to showing them.


