**DONATIONS OF SECURITIES:**

*Background*

In the May 2006 budget the federal government removed the capital gains tax on listed securities including stocks, bonds and mutual funds donated to charities. This is now the most tax effective way to donate to charities, including Rainbow of Hope for Children. The table below illustrates the tax advantage of donating securities as compared to selling securities and donating cash. The net effect is that the donor saves the tax on the capital gains. In the case illustrated, assuming a marginal tax rate of 48%, this amounts to \$920. For individuals with lower marginal tax rates the saving will be proportionally lower. Rainbow of Hope has now put in place the necessary arrangements for you to donate securities as described.
