2022 FCCLA STATE LEADERSHIP CONFERENCE LOCAL MEMBER CODE OF CONDUCT

- 1. Participants shall dress in appropriate business-like attire for general sessions, workshops, competitive events, and meals. (Jeans, leggings, midriff tops, tank tops, sneakers, work boots, Uggs, etc. are not appropriate.) Clothing that is too tight, too short and/or too revealing is not business attire.
- 2. Identification badges shall be worn visibly at all times during the conference.
- 3. Participants shall respect the rights and safety of other hotel guests and conference attendees.
- 4. Participants shall behave in a courteous and respectful manner, refraining from language and actions that might bring discredit upon the FCCLA association.
- 5. Participants shall refrain from verbal, physical, or sexual harassment and hazing or name-calling.
- 6. Participants shall participate fully in all appropriate conference activities, general sessions, workshops, business meetings, meals, etc. for which he/she has responsibility.
- 7. Attendees shall participate and pay attention in workshops and refrain from speaking out of turn. Disrupting a speaker or other members in a session is not acceptable.
- 8. Participants will exercise table manners during meal functions and give the speaker their attention. Talking during general sessions when a speaker is addressing the audience is disruptive. Members who disrupt speakers will be asked to leave.
- 9. Participant should be prompt and prepared for all activities.
- 10. Participants shall be willing to take and follow instructions as directed by those responsible for the activity.
- 11. Participants shall avoid places and actions that in any way could raise question as to moral character or conduct.
- 12. Participants shall treat all participants courteously, fairly, and equally.
- 13. Attendees shall not damage or deface property at any FCCLA conference. Trash should be disposed of immediately in the appropriate containers. Damages to any property will be paid for by the participant or his/her school district.
- 14. A member shall remain in the conference area at all times and not wander throughout the hotel unless accompanied by the chapter adviser or chaperone. Members shall keep his/her chapter adviser(s) informed of his/her activities and whereabouts at all times.
- 15. Participants shall not use a cell phone during any meetings, workshops, or competitions.
- 16. Participants shall not violate any local, state, or federal laws (i.e. possession of alcohol, narcotics, weapons, smoking, or vaping).
- 17. Members shall remember the FCCLA mission and purposes and shall act accordingly.

A member who violates or ignores any of the above code of conduct subjects himself/herself to:

*Being removed from the FCCLA conference and sent home at his/her own expense after consultation with his/her chapter adviser(s). *Having any honors, medals and/or office withdrawn.
