**Approve Agenda:** A motion by John Miller seconded by Craig nelson to approve the agenda. Motion carried by unanimous voice vote.

#### **New Business:**

- 1) Discuss/Approve optional plans regarding water patrol presence on the Chain O'Lakes.
  -Lots of discussion on what could happen if we get out of the agreement. Below is a list of questions to answer.
  - -Jim Peglow:
    - -Why was the Sheriff not invited to the meeting?
    - -What is truly best for all the citizens in the towns and the county?
  - -Are we better off having a joint law enforcement group for the Town of Farmington and the Town of Dayton?
    - -What would it look like if we went with our own law enforcement?
    - -How many employees and how many hours would we want?
  - -What would the difference between a town constable and a reserve or a sheriff deputy?
    - Why is part of the county under this agreement and the other isn't?
    - -What can we do with \$18 an hour to have someone patrol on the lakes?
    - We cannot change this agreement for 2021.

### -Jeff Barlow:

- -Why would they patrol the Wolf river without an agreement but not the chain?
- -Where and when was the meeting to have specific hours and a dedicated seasonal fulltime officer?
- -Is it fair to say that these guys (patrol officers) know when they need to be there? -Caroline Murphy:
- -The cost factor for the Towns to have their own constable would be far more costly than what we have now.
  - We had a chair meeting with the sheriff.
  - -Hours have to be offered to a regular officer first.
  - -The reserve officer would be a cost savings.
  - -We can amend this agreement.

-John Miller:

- -We get the sheriff's report monthly and it has a hundred plus incidents. Do we really want to get involved in that?
  - -The Wolf river has different rules.
- -The chain is a defined body of water where the Towns set the rules and therefore it is our responsibility as the board for the towns to do that.
  - -What would the liability be for a town constable?
  - -An officer will sign up 9am 12pm to accommodate their personal needs.
  - -They are not corresponding with the hours of need on the lakes.
  - -We need an agreement that is clear on what we really want.
  - -We can revise the current agreement if it is excepted by all parties.
- a) Look at what hours we want does it make sense to encourage the sheriff to hire someone like last year?
  - b) Do we need to have this extra patrolling costs for our citizens?
- c) Each board needs to come up with their options and bring them to the table at the next group meeting.
- -Jerry Murphy:
- If you are open to a suggestion, you need to negotiate before you ask the sheriff in and then ask him what we can do to meet this? There is a level of brainstorming that needs to be done before bringing in the next party.
- -Mark Jensen:
- -Are you saying you have a hard time having your township pay water patrol expenses?
- -Caroline Murphy: Next group meeting March 29th at 8 am.
