Town Square Art Affaire will be held on Friday and Saturday (set-up on Thursday available), in conjunction with the Cathedral City Hot Air Balloon Festival and sponsored by the newly opened Agua Caliente Casino.

Open to all media of original Fine Art and Fine Crafts. All work will be juried. Categories will be limited. No commercial, manufactured, imported, mass produced or purchased for resale items will be accepted. No clothing. No representatives.

Participants must supply their own displays. Each participant is responsible for the safety and Liability Insurance of their own display and merchandise. West Coast Artists and Cathedral City assume no responsibility for loss or damage to merchandise, display, canopies or participants. Outdoor lighting and electricity will be available. Overnight security will be provided Thursday and Friday evenings for your convenience. Show hours will be from 10 am to 6 pm on both Friday and Saturday.

Entry fee is \$225.00 for a 10' X 10' or \$350.00 for 10' X 20' space with 10% commission on all sales. Corners (if available) are an additional \$50. Please submit 4 photos of your work, a photo of your display (canopies, if used, must be white only) and a check in the appropriate amount payable to West Coast Artists (we accept credit cards and Pay Pal). Applications can be emailed to info@westcoartists.com.

Deadline for entry is September 1, 2021. Anyone wishing to cancel after confirmation must do so by October 18, 2021, to receive credit toward another show. Once an exhibitor is accepted into the show the entry fee is non-refundable. If the event is cancelled due to COVID your entry fee will be refunded.
