CONSUMER FIREWORKS SALES GUIDE SHEET

1. Gather Required Documents:

- **Copy of Kentucky State Fireworks Sales permit and Storage Notification Report, available from the Kentucky State Fire Marshal's office, 502-573-0369 or online at <http://dhbc/ky/gov/fp/fw/default/htm>**
- **Proof of Insurance**
- **Agreement/lease (in writing) with the land owner to allow fireworks sales on their property**

2. Complete the City Occupation License Application

- **Available at City Hall Monday-Friday 9:00 AM-4:00 PM. Application may be downloaded at www.horsecaveky.com**
- **Attach the required documents to the application**
- **Pay \$51.00 license fee (3 months) at City Hall, 121 Woodlawn Ave., Horse Cave, KY for occupation license. (LICENSE NOT APPROVED UNTIL SIGNED BY HORSE CAVE FIRE CHIEF)**

3. Schedule a Building Inspection

4. Schedule a Facility Inspection

- **Contact Fire Chief Donnie Parker, 270-218-1356 for appointment**

5. License approved by Fire Chief (see pg 2 for facility inspections standards)

FACILITY INSPECTION STANDARDS

- **MINIMUM 1000 FT FROM ANY OTHER FIREWORKS SALES**
- **NO MOTOR VEHICLE OR TRAILER USED FOR STORAGE OF CONSUMER FIREWORKS SHALL BE PARKED WITHIN 10 FT OF THE TENT EXCEPT DURING ACTIVE DELIVERY, LOADING, OR UNLOADING OF FIREWORKS**
- **PORTABLE GENERATORS AND FUEL FOR GENERATORS MUST BE LOCATED AT LEAST 20 FT FROM TENT**
- **AISLES MUST HAVE MINIMUM 48" CLEAR WIDTH**
- **MAXIMUM TRAVEL DISTANCE TO AN EXIT IS 35 FT IN A NATURAL AND UNOBSTRUCTED PATH**
- **CURRENT STATE PERMIT AND CITY LICENSE DISPLAYED**
- **" NO SMOKING-FIREWORKS" SIGN, MINIMUM 2" CONTRASTING LETTERS POSTED AT MINIMUM TWO FRONT LOCATIONS**
- **"NO DISCHARGE OF FIREWORKS WITHIN 200 FT" SIGN**
- **MINIMUM 2 FIRE EXTINGUISHERS (2A MULTIPURPOSE DRY CHEMICAL)**
- **SALES TO OR BY INDIVIDUALS LESS THAN 18 YEARS OLD ARE NOT PERMITTED**
