#### 6. Field Reports

#### Highfield Road

Rubbish Pile in corner of field

JL bought up the rubbish in the corner of Highfield Road. There are 2 large piles. They are not items that could be burnt and they are to close to the houses.

Possible create additional car parking in this area.

First clear the rubbish - Hire a skip

PC stated that a 4 yard skip from Mick's Refuse is £195.

RJ offered to get a quote for the hire of a digger from Stable Hire to remove the earth that was left over from laying the water system. PC said if it is no more than £200 we should just go a head and do it so as not to wait another month.

RJ put forward a Skip with a maximum price of £250, and a digger on a weekend hire.

PC added a maximum budget of £550.

Agreed to hire skip and digger.

Some of the committee do not want to wait for the covid restrictions to be lifted to interview the candidates.

There will be Teams meeting interviews held on Wednesday 28<sup>th</sup> April. One at 7:00 and one at 8:00pm.

Replacement of ride on mower from insurance money

A replacement has been found from the supplier. The Society will have to add approx £200 to the insurance claim. There is currently no mowing going on at Highfield Road until the replacement is delivered.

AVM asked if this is a mower for all four fields.

RJ said that this was to replace the stolen Highfield Road ride on mower that we have insurance money for.

AVM asked how often the grass is cut.

JL – Once a week.

AVM asked how we cut the grass on the other fields.

RJ said that Washbrook Road and Grafton Road do not have the volume of grass to cut as the other fields. At Bedford Road there are 3 of us that do the mowing. It would be nice to have a ride on mower at Bedford Road but we do not have a build to store one in.

MC asked why we do not have one ride on to share between all the fields.

RJ – The problem with that is the moving of the mower.

SW thought it had been agreed to have a mower on each field.

RJ – Bedford Road would have to have a new building as well to keep in. That would make cost prohibitive.

SW thought MC was going to get a mower.

MC said he would like to get a second hand one. It would be built better than a new one. But RJ was concerned about paying a large amount in cash. MC admitted that buying one second hand the sellers would not want a bank transfer.

MC said that if we are buying one for Highfield Road we should share it.

RJ – One of the reasons that the old one at Washbrook Road got broken was because it kept being moved between Highfield and Washbrook Road's.

MC – said may be that was because AJ and RJ did not put it on the trailer properly.

RJ & AJ pointed out to MC that they were not involved with the moving of the mower.

AVM asked JL to remind him of the cost of the mower proposed to buy

JL - £1799

AVM said if the field needs it the field needs it.

PC asked how much did we get back from the insurance.

PDS - £1600

RJ said would have to add £200 as the insurance company reduced for wear and tear on the age. PC asked if the insurance is still "live"?

RJ- It is part of our general insurance

PC so we will only have to pay the £200 extra. We should just do it.

MC feels that the mower should be shared with the other fields.

AVM states that we should buy one for each field, only £6000, we have the money just sitting in the bank earning next to nothing.

MC agrees but we could invest the money in property.

AVM – we are talking about a mower for Highfield Road. If need one on Washbrook Road, one for Bedford Road we should just get them.

MC – lets get 3 mowers

RJ – Bedford Road does not a build to store one in.

AVM suggested replacing the 2<sup>nd</sup> shed at Bedford Road.

RJ – the area is not large enough.

RJ – AVM ideas are a good idea. We will in the coming years may have to look at the Society buildings, as they are old and may have to be replaced.

AVM – why do we not look at replacing the building.

RJ says – lets take one thing at a time. We had a ride on mower at Highfield Road stolen, We have had the insurance money. The mower was original agreed by the members at an AGM. Lets use the money to replace it and have a separate debate on our other requirements.

MC says that Washbrook Road needs a ride on mower.

RJ suggests that we order the replacement for Highfield Road and then do field visits to Washbrook Road and Bedford Road and measure up what we think our requirements are on the amount of grass to be cut on both of these fields. This is what we did for Highfield Road and presented it to the members at an AGM to justify the purchase of a mower.

JL – Has no opinion on who owns the mower it belongs to the Society or uses it as long as it is at Highfield Road when JL wants to cut the grass. JL wants to be able to go to the field at it is there available.

SW bought up by looking on ebay that we could buy three second hand ones for £2100. MC we would get better ones by paying cash.

RJ is not comfortable buying second hand, no warranties, we don't even know if they would be stolen.

RJ Proposed that the replacement is purchased from the insurance money with the addition of  $\pounds 200$ . Seconded by AJ

SW will it be shared by the three fields.

RJ as long as it is at Highfield when JL needs it.

MC respects what JL has said but he can not be the sole keeper of the mower. It should be used at Washbrook Road Monday, Highfield Tuesday....

RJ said you can't say that as you do not know what the weather is going to be.

MC so we are all going to fight over the mower on a Monday.

RJ no. We are replacing a mower that was based at Highfield Road. As said before we can measure the grass at the other fields to see what is appropriate and cost it up

MC – Why should Washbrook Road be pushed to the back of the queue.

RJ – I knew some of you would try and stall the replacement..

In Favour Against Abstained RJ, AJ, SW, JL AM, PC, MC AVM, DF MC will vote against unless Washbrook Road is looked after as well. 4 In favour, 3 Against, 2 Abstained Mower will be ordered

DF feels aggrieved that he used take the Washbrook Road mower to Highfield Road. When Highfiled Road got theirs it was never offered to DF at Washbrook Road. He has to use hand mower, sometimes his own.

RJ added that he uses his own at Bedford Road.

DF added that RJ uses the tractor on Bedford Road.

RJ pointed out that the tractor has not been used since the plots have been put in on the upper part of the field.

RJ said that DF and RJ should look separately at what is required for the other fields. AVM

Asked what would be the time scale.

RJ said for the next meeting.

AM said he won't do it.

MC said again why are we not buying 3 ride on mowers.

RJ because we would have to have a building at Bedford Road.

MC get 2 mowers, Why does Washbrook Road has to be at the back of the pile every time.

RJ – That is not true.

MC – lets get 2 mowers.

Other committee members agreed.

RJ will get prices for a self propelled mower for Bedford Road.

<u>BR member</u>

RJ - Their emails are contradictory. First one says that RJ spoke to them, the second says it was PS. I have them looked by an independent. RJ just wants it recorded that the member had lied about him.

AVM & PC stated they had not seen their emails.

RJ pointed out that the emails are in the last meetings minutes.

AM was not happy that RJ has had the emails looked at by an outsider.

RJ stated that the names had been removed. PC feels that RJ is victimising the member now.
