### **Annual Meeting**

The Annual Meeting of the Lakeside Condo Association was held on Saturday, February 8th, in the Clubhouse. Between actual owners present, and Proxy Statements returned, a quorum was in attendance. Reports from the Directors and Committee Representatives were given. It appears that a settlement with the insurance company regarding re-roofing of the remaining 9 buildings (8 Villas and the Clubhouse) is not imminent. The BOD may need to consider withdrawing funds from the Roofing Reserves and use remaining monies from the Hurricane Irma payout to complete the work if a negative outcome is received from the insurance company. Local bids for the remaining work appear to be about 1/3 less than the cost two years ago. The meeting lasted about 25 minutes. Full notes from the meeting will be published on the website when available. Board VP Tony Caniglia resigned after having served 7 years on the BOD. Tony has also been very active over past years doing volunteer maintenance work on the Lakeside property. *Thank you, Tony!*

# **Financial News**

- The 2020 budget that was adopted at the February 8th Annual Meeting is \$255,200.
- The guarterly Maintenance Fee per unit in 2020 is \$550, a \$20/yr. increase from 2019.
- FY 2019 ended being slightly over budget due to unplanned lift station expenses, replacement of dead palm trees, a part-time Maint. Contractor and new external fire extinguishers.
- All bank balances reconciled with operating statements at the end of 2019.
- Reserve Account balances at the end of 2019 were as follows:
  - Roofing: \$277,498 Paving: \$64,027 Painting: \$68,845
  - Pool: \$10,915 Betterments: \$3,355 Maintenance: \$20,101
- Remainder from Hurricane Irma Insurance Proceeds at the end of 2019: \$57,083.68
- Current reported asking prices for condo units at Lakeside and Lakeshore are in the \$115,000 and up range!

# **Updated Lakeside Owners Directory**

An updated version of the Lakeside Owner's Directory was distributed by President Katy Curley in late March to residents still here, and will be mailed to owners who have left for the season. The last directory was published in 2016. Since then many units have changed ownership, so a new directory was in order. While it would be convenient to have this information on the Lakeside website, and allow for easy updating, privacy and security issues make this option not currently feasible. A check of the directory disclosed the following information regarding the home state of current owners:

FL - 42 (including 27 permanent Lakeside residents), MA - 14, OH - 12,


NY - 11, MI - 9, PA - 7, NH - 5, IL - 4, NJ - 3, CT - 2, RI - 1, KY - 1,

Currently, some 3-4 units are known to be on the market, so the just published owner's list will change, once again, in the not too distant future.

# **COVID-19 Virus**

COVID-19 brought a dramatic change to the activities at Lakeside and the surrounding area this year. The annual going away party, always a favorite, scheduled for March 23rd, was cancelled, following federal guidelines for numbers of people at gatherings and proximity to each other. The cessation of bocce, cards and bingo followed suit, in mid March, also based on numbers of people at a gathering and proximity to each other. Spring training for MLB teams in our area (Red Sox, Rays, Twins, Braves) was cancelled mid season, leaving baseball fans without places to go to get a glimpse of the upcoming MLB season. With the closing of the Pt. Charlotte Mall and the majority of restaurants in the area on or around March 17th, an early exodus of owners start-



ed. Finally, following the advice of Lakeside's attorney, the Board of Directors voted to close the pool on April 3rd until further notice. Hopefully, by next fall things will be back to normal!
