**GEYER: (Read by Mayor Lincoln)** 

**Resolution No. 5-10-2014:** "To hire Linda Goodlin as a full-time Clerk in the Tax Office beginning August 1, 2014; salary and benefits to be determined by the current labor contract."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Zolbrod, Ritch, Karpiak and Lincoln. The majority of the votes being affirmative, the resolution was adopted.

**Resolution No. 5-11-2014:** "To hire Rebecca Staub as a seasonal Clerk in the Tax Office beginning August 1, 2014; compensation will be \$7.50 an hour, not to exceed a total of \$3,600.00 for the current budget year."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Zolbrod, Ritch, Karpiak and Lincoln. The majority of the votes being affirmative, the resolution was adopted.

**Resolution No. 5-12-2014:** "To authorize an expenditure of \$202.50 for an orientation and training period for the new hire in the Tax Office. This will reflect \$7.50 an hour for a total of three hours a day from July 21, 2014 through July 31, 2014; money to be taken from the Miscellaneous Contingency line item."

#### KARPIAK:

Public Works Report

Karpiak discussed storm inlet repairs and maintenance, flood prevention, York Avenue Bridge will be restricted to one lane, West Penn Power Luncheon, and LED Lights throughout the City could save 75% on the electric bill and discussed Smart Meters

## RITCH:

**Resolution:** "To place an invitation for bids for the sale of City owned property located on York Avenue, Parcel ID #05-03-0100 and Parcel ID #05-03-0101; to be sold as one lot, and direct the City Clerk to advertise these parcels for bid. Bids are to be received no later than Monday, June 9, 2014 at 4:00 PM and to be opened on June 12, 2014 at 5:00 PM at City Hall during the regular City Council Meeting."

Karpiak suggested holding off on the sale until they do something with the bridge that is located beside that lot.

**Resolution was tabled:** Affirmative were Councilmen Karpiak, Geyer, Zolbrod and Mayor Lincoln. The majority of votes being affirmative, the resolution was tabled.

**Resolution No. 5-13-2014:** "To approve the Light Up The Sky Event at Cats Courts on June 9, 2014 at 8:00 PM; event to benefit the Care for Cat Fund."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Zolbrod, Ritch, Karpiak and Lincoln. The majority of the votes being affirmative, the resolution was adopted.

**Resolution No. 5-14-2014:** "To transfer \$6,000.00 from line item #01380-380.013, Pavilion Rentals, into line item #01430-145, Seasonal Employees."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Zolbrod, Ritch, Karpiak and Lincoln. The majority of the votes being affirmative, the resolution was adopted.

**Resolution No. 5-15-2014:** "To transfer \$3,000.00 from The Parking Lot Fund into line item #01430-145, Seasonal Employees."

Ritch stated the City is hoping to hire five employees noting one will be working on the parking lots and parks and one in City Hall. He added there is a course of action to replenish the \$3,000.00. Ritch stated they will be going around to the parking meters and emptying them again.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Zolbrod, Ritch, Karpiak and Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Ritch stated the work duties of the summer employees will be trimming the parks, City owned and Health Department properties, police station, City Hall, pavilion rentals, parking lots and other routine Public Works maintenance under the direction of the Public Works Supervisor Vernon Ohler.

**Resolution No. 5-16-2014:** "To hire Kyle Karwatsky and Shane Beneke as 12 week employees for the Public Works Department beginning May 21, 2014; salary will be \$7.50 per hour and 35 hours per week."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Zolbrod, Ritch, Karpiak and Lincoln. The majority of the votes being affirmative, the resolution was adopted.

**Resolution No. 5-17-2014:** "To hire Ryan Huey, Michael Parlak and Justin Peperak as 10 week employees for the Public Works Department beginning June 9, 2014; salary will be \$7.50 per hour and 35 hours per week."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Zolbrod, Ritch, Karpiak and Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Ritch stated with the transferring of funds there is still \$2,325.00 and the City is looking at applying that to a part-time janitor they hope to hire in September to clean City Hall.

## **ZOLBROD:**

Fire Department Report Health/Code Officer Report New Haven Hose Report

Mayor Lincoln stated New Haven Hose will be sending out their fundraising letters and asked the public to give if they can.

**Resolution:** "To introduce Bill No. 3, Ordinance No. 1508, An Ordinance of the City of Connellsville to require the registration of vacant or abandoned structures and to govern the conditions and maintenance; by providing the standards for supplied utilities and facilities and

other physical things and conditions essential to ensure that structures are safe, sanitary and fit for use."

Karpiak stated there is a clause in this ordinance that makes it unsafe and that is by leaving the power on vacant structures. He stated he has no problem if the power of the abandon structure was off. Karpiak stated many times buildings catch fire because power is on. He added if the water freezes then the pipes will bust. He also stated he would like the 10% out of the ordinance. Karpiak questioned why he didn't get drafts of the ordinance.

Currey answered that the idea of the electric being on is to utilize the building. He explained the 10% in the ordinance and noted the wording can be changed in the ordinance.

Karpiak stated he does not agree with the ordinance noting you cannot get insurance on vacant structures and if you do it costs a lot of money. He also stated that by making owners keep the electric on we are making them violate the rules. Karpiak stated he wants that taken out.

**Resolution was tabled**: Affirmative were Zolbrod, Geyer, Karpiak and Mayor Lincoln. The majority of the votes being affirmative, the resolution was tabled.
