Meeting Report

The November meeting featured Jason Bulkley, a Law Enforcement Ranger with the BLM, talk about "Archaeological Resources and Public Lands law Enforcement".

The BLM enforcement role is to

- Enforce the Antiquities Act of 1906 and the Archaeological Resource Protection Act (ARPA) of 1979
- Protect public resources
- Public safety of public land users



Jason Bulkley

Jason described the various aspects of the two resource protection laws. The Antiquities Act of 1906 was determined to be to constitutionally vague in a court case in 1974. In 1979 congress passed ARPA. This act essentially protects material remains of past human life or activities of archaeological interest of at least 100 years of age. A key passage of this law reads "The purpose ... is to secure, for the present and future benefit

of the American people, the protection of archaeological resources. Archaeological resources on public lands are an irreplaceable part of the nation's heritage".

The BLM rangers perform their duties in one of two ways.

- 1) Proactive patrols focus on
 - Site monitoring and documentation
 - Site steward ride along patrols
 - Focused patrols
 - Prevention through signage, education and outreach with the focus on education.
- 2) Reactive Activities include
 - Responding to reported activities
 - Investigations

Jason believes that there are two types of people who will cause damage to archaeological resources. The first is someone who does something on the spur of the moment. He believes that these people best benefit by an education program. The second type of person is the "full time collector" who he believes should be prosecuted to the full extent of the law.

The law enforcement ranger program is understaffed. There are currently 3 rangers assigned to the Arizona Strip (4 million acres), 2 assigned to Southern Utah (650,000 acres) and 0 in Cedar City (5 million acres). The rangers need your help. You can help by becoming Site Stewards and by reporting any observed damage directly to law enforcement – caution is a must.
