This is the complete EMDR Basic Therapy Training approved by EMDRIA, formerly known as Level I and Level II. Participants will learn the EMDR psychotherapy approach, the basic eight-phase EMDR protocol, the Adaptive Information Processing Model, and how to incorporate EMDR into your practice. This course will consist of didactic presentations, demonstrations, supervised practicum, and case consultations. Participants must attend the full training and five 2-hour consultation groups to receive a certificate of completion in EMDR Therapy. Approval of partial programs will not be granted.

Required Reading: Eye Movement Desensitization and Reprocessing: Basic principles, protocols, and procedures, third edition, by Francine Shapiro, PhD, EMDR Therapy originator.

Qualifications for Attendance: A clinical background is essential for the effective application of EMDR. Attendance at the workshop is limited to mental health professionals who, at a minimum, are enrolled in the practicum phase of a Master's degree or Doctoral degree. This course is appropriate for licensed and pre-licensed mental health professionals including Psychologists, Marriage and Family Therapists, Clinical Social Workers and Professional Clinical Counselors.
