Connellsville City Council MINUTES SEPTEMBER 21, 2021

This meeting of the Connellsville City Council was held this evening at 6:00 PM. Attending this meeting was Mayor Lincoln, Council members Keedy, Karpiak and Tzan. Councilman Topper was absent. Also attending was City Clerk Ohler and Solicitor Witt.

PLEDGE OF ALLEGIANCE AND MOMENT OF SILENCE: Pastor Matt Goldsberry led invocation

REMARKS FROM VISITORS/PUBLIC COMMENTS:

Lee Winterhalter, Opioid prevention discussion.

Rev. Matt Goldsberry, Thanked Councilman Bob Topper for his work on the new Quality of Life Ordinance and having Gibson Terrace area cleaned up.

Mayor Lincoln thanked the Fayette County Housing Authority and Fayette County Commissioner for supporting the new housing with homes in that area.

Rev. Matt Goldsberry invited City Council to the church on a Thursday evening around 7 PM to see them make a difference in the lives of children in the city.

Dr. Frank Jacobyansky, President of the Recreation Board. He announced they raised over \$30,000 this year for the parks. He added they have two large projects they would like to pursue at the parks: one being replace the stage at Yough Park or upgrade it and putting in more parking at East Park.

Mayor Lincoln replied that he doesn't support putting money into a stage that is in good shape.

Dr. Jacobyansky explained that there are seven spaces to park at East Park. He added it is a beautiful park and will be utilized more often now. He also noted the need for handicapped parking and easier access to carry items to the pavilions and explained that he and Jason Bandimer measured and found a way to add 25 parking spaces. Dr. Jacobyansky questioned how the Recreation Board can go about this project and asked City Council for permission to pursue it. He added Kerri Bell, the City's Engineer, has agreed to assist with the design. He then asked how the Recreation Board can go about pursuing this project and get it done.

Councilman Karpiak addressed the use of the Public Works employees to work on the parking at East Park. He stated the city does not have the equipment to complete that project and there is not enough man-power to assist. He added that department has one- and two-man crews. Councilman Karpiak suggest the Recreation Board get bids on that project.

Dr. Jacobyanski questioned who is responsible for getting bids for this project.

City Clerk Ohler stated that he will do it.

Mayor Lincoln explained to Dr. Jacobyanski that the Recreation Board would bring the project to Councilwoman Tzan and she would bring it before City Council. He also added the people need to use the 75 parking spaces that East Park has down there and explained how to make that easier. He further added the 25 spaces that the Recreation Board would like to add would be great for handicap parking.

Stu Adams discussed Hill Grove Cemetery. He stated he has taken upon himself to cut the grass and weed eating at the cemetery. He showed City Council a picture of his vision for the cemetery. He noted the two young men that were getting paid by Fink Funeral Home to cut the grass has now given him permission to take over the very small funding account which will expire this year. Mr. Adams stated he wants to bring life back to that old cemetery by creating a pay-pal account so people can fund the "existing" fund. He notified council there is over 100 tombstones overturned. He added he wants to make a difference and that he will be reaching out to the churches and boy scouts and volunteers. He noted it is an eyesore but something fantastic can be done. He stated the he can cut some trees down but would like the city to carry them away. He stated he will be talking with Senator Stephano and other to explore grants. He clarified that he does not want to lay a burden on the city and he realizes that part of the cemetery is in the township. He stated that he is seeking corporate funding from family and friends and corporates from his employer. He stated Mr. Heath from Finks Funeral Home is allowing him charge of what little money is left to care for the cemetery. He stated he will be installing two American Flags this week.

Mayor Lincoln thanked Mr. Adams for his work and goals with the cemetery. He stressed the need for a "Board" that is not part of the city, to take over that cemetery. He also added Mr. Adams would be great to take that charge for a new board. Mayor Lincoln stated there are people interested to be on a board for the cemetery. Mayor Lincoln asked Councilman Karpiak if Superior Mulch takes trees.

Councilman Karpiak stated they do not take trees depending on what tree it is.

Mr. Adams replied they are non-pine so they are clean to burn in the house. He stated he is limited in his mobility but can drop the tree but cannot move it. He added it is great for heating and firewood.

Mayor Lincoln stated a few ideas the city has and noted Mr. Adams will be the point of contact on the cemetery for sure. He requested Mr. Adams create a Facebook Page for the cemetery.

They discussed financial ideas and ways to obtain funding for the cemetery.

Mayor Lincoln requested Mr. Adams keep in contact with Vernon Ohler, City Clerk.

James Hannis discussed Nelson Bus Lines. He stated he would like to see a change in parking at the satellite center at Highlands Hospital. He stated the issue is on Gibson at the curb.

Mayor Lincoln questioned if this could go through the Traffic Committee.

City Clerk Ohler stated yes, it would be a Traffic Committee request.

Solicitor Witt explained it would go through the Traffic Committee who would bring it to City Council to vote on.

Mayor Lincoln requested Chief Hammerle take a look at the situation tomorrow.

Mr. Hannis spoke on another note regarding Judge Haggerty's program. He stated the program is people having to work to pay off their fines.

Mayor Lincoln stated he knows the program and Judge Haggerty has a sign-up list. He stated that people sign up and then the day of work, not everyone who signs up actually show up.

Police Department Report given by Chief Hammerle

Chief Hammerle notified City Council of the calls taken in South Connellsville territory.

Mayor Lincoln discussed the hiring of two new police officers and thanked the Civil Service Board, noting that is who the city goes through to hire officers. He also thanked Chief Hammerle for his work and the stress he went through putting everything together to hire two new officers.

Hammerle stated he can retain the seventeen applicants that applied for a period of two years. He further added there are possible retirements upcoming and there are a lot of good people to choose from on this list.

Mayor Lincoln noted Ryan Layton has been a long-time member of New Haven Hose and is the City's EMA Coordinator.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmembers Tzan, Karpiak and Keedy and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 9-8-2021: "To hire Ryan Francis as a patrolman for the Connellsville Police Department starting October 18, 2021 at a salary reflected by the collective bargaining agreement between the City and the Connellsville Police Officers Association; Funds will be taken out of line item 410.142."

Mayor Lincoln added Ryan Francis has a military background.

Mayor Lincoln questioned Chief Hammerle if the new K9 vehicle from the County is ready.

Chief Hammerle answered they are still waiting for parts to come in for the vehicle.
