MINUTES CODE ENFORCEMENT BOARD MEETING December 12, 2016

The Horse Cave Code Enforcement Board met in regular session on Monday, December 12, 2016 at 5:00 PM in the Council Chambers. Present were board members Don Ford, Dean Froedge, Tim Tucker and Code Enforcement Officer Ken Russell.

In the absence of chairman Schroder, Tim Tucker was selected to chair the December meeting. He declared that a quorum was present and called the meeting to order. The minutes of the October/November, 2016 meeting were presented. Froedge made a motion to approve, Tucker seconded. Motion carried 3-0.
