I am a Certified Hypnotherapist through the National Guild of Hypnotists as of 2011, and I complete annual continuing education to maintain my certification. I am also certified in Age, Womb, and Past Life Regression Hypnotherapy. In addition, I am a trained Professional Intuitive, Spiritual Life Coach, Certified Soul Realignment Practitioner, Certified Karuna & Usui-Tibetan Reiki Master Teacher through the International Center for Reiki Training, and an RYT 200 through the Yoga Alliance (Registered Yoga Teacher).
