Compliance: Ensured the conformance to rules, policies, and law by implementing the Federal Protective Service process for managing risk to federal facilities. As someone who monitors and conducts activities in the Protective Security Officer (PSO), Facility Security Assessment (FSA), and Technical Countermeasure programs, I ensured that activities are completed in compliance with Interagency Security Committee (ISC) standards. Through these programs, I ensured relevant parties comply with all applicable rules, policies, and laws; and I conducted inspections to ensure compliance and bring violators into compliance. As a collateral duty I was placed in the role of Contracting Officer's Representative (COR); I was primarily assigned two statewide guard contracts with a total annual budget of over 10M in taxpayer funds, during this time I was the primary approving official for the release of funds. I was responsible for ensuring that guard service vendors remained in compliance with their contract, quickly addressing issues and rating overall contract performance.

Guard Force Operational Oversight: Coordinate with other personnel to oversee and monitor PSO performance by physically visiting the facility, reviewing the post to ensure that the guard is in the proper uniform and meeting all operational needs and documented Post Inspection findings through these visits and by conducting general impromptu inspections, conducting PSO file reviews, and providing

responses to requests for routine case file information. Additionally, overtly and covertly evaluate PSO performance against the standards described in the contract.

<u>Guard Force Training Oversight</u>: Monitored and conducted training for the PSO workforce including overseeing access control operations, screening operations, incident response, reporting, initial and recurring certification and qualification, enhancement and management of the PSO training curriculum, and ensuring proper oversight and monitoring of training and qualifications.

Technical Countermeasures Management and Oversight: I conducted planning, design, implementation, testing, and verification and validation of technical countermeasures. I ensured 24/7 availability to Designated Official for any countermeasure maintenance or repair issues. Working knowledge of most locking devices and ability to bypass systems as well as electronic countermeasures.

<u>Technical Countermeasure Contract Administration Support</u>: I inventoried all FPS-responsible technical countermeasures for 32 facilities within my assigned portfolio, including maintaining knowledge of any technical countermeasure warranties in place as well as Preventative Maintenance Inspections (PMI) that the vendor is responsible for conducting.

Investigation: I conducted numerous investigations of alleged or suspected criminal violations or noncompliance with federal, state, and local laws, rules, policy, regulations, or other mandatory regulatory requirements by individuals or organizations related to the protection of critical government infrastructure and key resources. I conducted surveillance and assessments to identify fraudulent situations and to uncover attempted violations and/or illegal activities. I performed preliminary criminal investigations in the federal workplace at the requirement of the responsible victims, Designated Officials, and members of the public by preserving crime scenes as trained, conducting comprehensive review of all available evidence, collecting statements, and assembling initial case packages for the Criminal Investigator. I conducted investigations by collecting information relating to criminal offenses and serve and execute search and arrest warrants, serve subpoenas and summonses, and make arrests as needed.

Inspection: I performed work conducting onsite inspections, citing violations and preparing reports of violations. Through the PSO, FSA, and Technical Countermeasure programs, I performed activities where I conducted inspections of federal facilities and worksites for compliance with, and fulfillment of, security system contracts and standards and meet with agency officials or share information with relevant personnel to ensure awareness of recommendations and mitigation steps and to improve the operations and conditions of facilities.

Manage and Conduct Post Inspections: I conducted post inspections of contracted guard forces to ensure proper qualifications such as licensing, identification, uniform, and knowledge of post-specific orders. I provide documentation of the efforts to the COR.

Post Orders: I initiated, update, and review comprehensive post orders in tandem with the COR. When acting as a COR I reviewed post orders to ensure validity and compliance with applicable contracts, policies and laws. I ensured post order books are up to date and contain all required information in accordance with post requirements.

Facility Security Assessment: I examined facility threats, vulnerabilities, and consequences and address facility-specific security issues by recommending security countermeasures in a whole array of Federal Facilities. I established schedules for FSA completion and monitor progress. I determined the Facility Security Level (FSL) in accordance with agency procedures and assess the effect of Design Basis Threat mitigation strategies.

Threat Assessment: I was the DHS Liaison for Fusion Centers within Florida, and worked with the Hillsborough County SO management to create a new Fusion Center while developing new intelligence sharing programs for the agency. My long standing and decorated performance in the intelligence sector provided me with an excellent working knowledge of threat management. As a result I became the Regional Subject Matter Expert for intelligence and threat management programs; for which I was recognized by the DHS Secretary and awarded the "Unsung Hero" award. I conducted threat assessments for all Federal facilities within the Central Florida area, special events and assisted other Federal/State/Local agencies in performing threat assessments as well as other law enforcement intelligence functions as requested through the Florida Fusion Center.

<u>Technical Countermeasure Management and Oversight:</u> I conducted Functionality Testing and Measure of Effectiveness (MOE) procedures for all Government-responsible technical countermeasures (e.g., Magnetometers, X-ray, Closed Circuit Television, and Intrusion Detection System) by monitoring functional operations and compliance with ISC requirements.

Enforcement: I performed uniformed and plain clothes law enforcement work involving a nexus to the protection of Federal Property/Personnel/Critical Infrastructure ensuring the protection of life, property, and the rights of individual citizens by enforcing and assuring compliance with statutes, laws, and government facility rules and regulations and protecting the civil rights of all persons on the property under the charge and control of the U.S. Government.

Law Enforcement Response: I regularly responded to calls for service at federal facilities to conduct initial incident response, preliminarily investigate possible violations of federal law, and applicable local law, including felonies and misdemeanors, make an arrest, document an incident, and conduct law enforcement liaison and coordination as necessary. I requested enforcement assistance when needed, coordinate emergency enforcement response to critical incidents and founded a Multi-Agency Rapid Response Team and work with my command staff to dispatch resources and track status for facilities.

Law Enforcement Policing and Patrol: I conducted surveillance and monitoring of suspicious activity, deterrence patrols, and community policing activities by interacting daily with all types of occupants and visitors of federal facilities within my portfolio. I used demonstrated knowledge, training, and abilities to conduct investigative detentions ("Terry Stops") with careful attention to protecting the Fourth Amendment rights of individuals involved. I conducted regular site visits, foot patrols, and interactions with tenants, incorporated intelligence lead policing as well as observe facilities within my portfolio in order to proactively deter crime. Due to my expertise in law enforcement and physical security I was assigned as the Regional Field Training Evaluation Program Coordinator; responsible for development, implementation and management of the law enforcement field training program for the Southeast U.S. (8 states in total). In this position I developed/implemented several publications and procedures adopted agency-wide.

Training: I was appointed to manage the Regional training program (SE 8 States/160 Federal Employees); I was placed in this position by the Regional Director due to serious shortcomings and mismanagement by my predecessor. I have served as the principal problem server for both the Regional Director and Deputy Regional Directors on numerous other issues; after assessing the current training programs/personnel/processes I replaced inadequate instructors, implemented common sense/effective programs, automated Regional training records (which were handwritten/paper files prior to my appointment) and revised/modernized outdated curriculum. As a result of the program's success I was consulted by other Regions throughout the agency to improve their programs, I was also sent to the Federal Law Enforcement Training Center (FLETC) on numerous occasions to participate in working groups as well as assisting as a guest law enforcement instructor when needed. I developed the first of its kind FPS Region 4 Tenant Safety & Security Guide, which provides easy to follow safety/security awareness, crime prevention and active shooter awareness materials for non-law enforcement Federal Agencies. I served as the primary Officer Safety and Active Shooter Response instructor for the District. I regularly delivered the following training

programs to Federal Agencies within assigned areas: Active Shooter Awareness/Prevention, Crime Prevention/Security Awareness, See Something, Say Something, IED Search Procedures and Suspicious Package Recognition/Safe Mail Handling.
