


THE NON-INDEPENDENT TERRITORIES OF THE CARIBBEAN: Statuses and Cooperation

WORKSHOP 1



8-12 November 2010

The United Nations officially recognized 16 non-independent territories of which 7 are located in the Caribbean. These are Anguilla, the British Virgin Islands, the Cayman Islands, Montserrat, the Turks and Caicos Islands, the U.S. Virgin Islands and Bermuda which is incorporated in the Caribbean despite its geographical position.

In fact not all non-sovereign territories of the Caribbean are included in the list. For example, the Netherland Antilles, Puerto Rico, the French overseas territories are not included, though they are objectively non-independent territories. Actually legal situations vary greatly. The primary objective of this seminar is to question the particularly limited cooperation between countries of the region, whose statuses under both international law and individual domestic laws of the states they depend on , are different. French local authorities have experienced recent developments, generated both by a desire of the French state to streamline local administration and by the consultation of the populations of the French territories of the Caribbean. Guadeloupe, French Guyana, Martinique and St. Martin do not have the same constitutional statuses while being all ultra peripheral regions of the European Union. The island of Saint Barthelemy, which has voted in favor of the constitutional status of "Pays et Territoire d'Outre-Mer" enjoys a greater autonomy akin to the one enjoyed by the Dutch, British and American, territories. The British and Dutch territories have also experienced institutional changes some of which surprising enough. The breaking up of the Netherlands Antilles, the integration of Saba, St. Eustatius and Bonaire in the administration system of the Netherlands can be compared to a certain extent to the changes observed in the Guadeloupean archipelago. Changes have also occurred in the British West-Indies. The government of Great Britain intervened directly in the affairs of the Turks and Caicos islands, limiting its autonomy regime in the name of good governance. In the Virgin Islands and Cayman Islands, constitutional changes have been adopted or are in progress. Beyond the differences what cooperation actions are implemented today? Which ones could help bridge the gap between territories whose histories and current events have so many similarities?
