U.S. Navy: Poisoning the Pacific

There is no secret that the U.S. Navy has been an ongoing force of destruction to the Hawaiian Islands for over 100 years now.

The relationship between Hawai'i and the Navy began as early as 1820 when an Agent of Commerce and Seamen visited the islands to look after American merchants in foreign places.

In 1893 the U.S. Navy were the forces that arrived to overthrow Queen Lili'uokalani with the threat of genocide against people

of Hawai'i. In 1897, after going door to door on every island, the Kū`ē Petition garnished over 38,000 signatures to present to Congress stating that people were loyal to the Kingdom of Hawai`i. Some time in recent years, Noenoe Silva was conducting a research and uncovered the petitions in an archive in Washington DC.

In the 1900 Congressional Debate, Senators argued the illegality of keeping Hawai`i but the Navy found Honolulu to be a perfect station to fight the Philippine-American War. During this time, the United States also attempted to annex the Philippine and Puerto Rican Islands. The Navy liked it here. They like it so much that they bring imminent danger to the people of Honolulu as a "good neighbor" gift, and poison the environment with toxins that even make the Military families sick. If the Navy is supposed to protect its citizens, then why is the Navy choosing to poison the people and Honolulu`s primary aquifer?

To protect her people, Queen Lili`uokalani abdicated her throne to honor the wrongful wishes of the U.S Navy, who claimed to be protecting the people. Why are they hurting Honolulu`s people now?

The U.S. Navy is <u>resisting efforts</u> to clean the aquifer from the harmful effects of the fuel leakage, leaving both military families and residents of O'ahu in danger of permanently losing their water supply.

In addition to poisoning the people, the fuel tanks are severely outdated. If a tax-paying homeowner were to have an outdated septic tank or gas tank, they would be held accountable a long time ago. The outdated system is at the end of its life span and is in an utter state of disrepair; yet the Navy continues to fight a state order to drain the tanks.

Brief History of Red Hill Fuel Tanks

Construction began on Christmas 1940 and was completed after the loss of sixteen lives during construction. The design was to hold 255 gallons of fuel in a facility that was safe from aerial attacks. RADM Chester Nimitz was the mastermind behind this effort.

Red Hill was leased by the U.S. Navy and was an area that contributed to the sugar and pineapple industries. Eventually, with strong-arm tactics - the Navy forced their purchase of the land containing Red Hill.

The technology and plans for the fuel tanks were so state-of-the-art that a project like this was never even tried before. However, a year before the attack on Pearl Harbor, the Navy planned to protect their fuel from an aerial attack from Japan. By the time the excavation and liners were complete, all of the cracks and holes were grouted and sealed. These facts are very concerning. Other records indicate that cracks were repeatedly filled during the process and the question of, "how much fuel has been leaking, and for how long?" is left to linger upon our imagination.

For years the tanks have been in a serious state of disrepair and have been leaching fuel. This information has been repeatedly brought to the attention of the U.S. Navy and has fallen on deaf ears. Unfortunately, the U.S. Navy is dedicated toward leading by immoral behavior and at the risk of both military families, Honolulu residents and the ecosystem at-large.

According to research done at the University of Missouri-Rolla, leaks have been occurring since construction of the facility and several of the sites have been used as waste storage.

If you are concerned about the issues of Red Hill, please write to your legislative representatives, the Navy, the White House, and all news media that you can think of. Bring this situation to the attention of the world, in hopes that the Voice of the People will be heard.


A woman who did not take the protocols listed on signage at Lake Waiau seriously, recently sent an apology to the DLNR for her behavior at a sacred site.

Shark Fishing Ban effective January 1, 2022

Act 51, also known as House Bill 533 passed in the last legislature making it illegal to capture, entangle, or catch sharks in waters surrounding Hawai'i.

The conditions of non-commercial include traditional permits Kanaka Maoli protocols, size specifications, and even prohibition of certain species.

Violations shall be judged as misdemeanors with fines up to \$10,000 per offense; plus administrative and legal fees.
