Budgets....

The 2013 City Budget was approved and submitted to DLGF. The Budgeted Expenses were 4% over those budgeted for 2012. Revenue was budgeted consistent with 2012. The primary purpose of this budget was to comply with DLGF and thus establish levies and tax rates. The TPA supported passage of this budget. Now the real work begins. The pattern over the last four years is that the administration typically spends about \$1 million per year less than the budgeted expenses; however the actual spending still exceeds the revenue generated. It will be critical that the city council maintain oversight on what is happening with city finances in order to reduce expenses to fall within the revenue criteria.

Principal for a day.....

What an exciting day! On November 14, I volunteered to be principal for a day at Fugua Elementary School. Mary Beth Harris is the principal and starts at 7:30 am every day. How she remembers the first and last names of all 385 students is amazing. It was clear that the relationship of the students to the staff and Mary Beth was one of trust and friendship combined with accountability. After resolving Chickenpox issues we were off to an interview where Mary Beth observed a teacher in action taking notes the whole time. We took a tour and visited every classroom. Later, we sat down and reviewed how she then relates her observations to the rating criteria. While this is a subjective system, it is very comprehensive in scope, yielding quantifiable ratings. Vigo County is truly blessed to

have a professional and dedicated organization such as the Vigo County School Corporation. Great Job!

Sewers....

The City Council passed the Sanitary District upgrade that is required by the EPA. This project will cost approximately \$140,000,000 and will be financed by a Revenue Bond. The financing will require an annual 15% increase in sewer rates for 3 years beginning in July 2013. There really were no options here. If the city did not move ahead, the Federal Government would come in and take over the Sewer Operation and set the rates. It was interesting that at the council meeting there were only two residents that had questions, and no one objected or complained.

Coke and Carbon Cleanup.....

The Coke and Carbon Clean Up Bond itself will be for \$7,000,000 - part of the \$140,000,000. These funds will be used for the first part of the Coke Plant cleanup. My comment was "won't that look like the sewer fees are going to pay for the Coke Plant cleanup?" While it could appear that way, the city had coordinated with the Indiana Finance Authority who offered a discount in conjunction with the EPA and a Green project and that by combining the two projects; they were eligible for a 0.005 discount on the entire bond. In essence it is free money in that the savings more than compensates for Coke Plant portion and that the discount would not be available on the \$133,000,000 without the "green" initiative. The discount of 0.005% equates to a \$ 7,000,000 savings. Compliments to the city for taking advantage of a great opportunity.

November 15, 2012- Deadline looms for homestead verification

Less than two months left to file form for property tax deduction

TERRE HAUTE — Nearing the end of a three-year notification process, Vigo County taxpayers have less than two months to file a homestead verification form to continue to receive a property tax deduction. Pinkcolored verification forms were first mailed with property tax bills in 2010, then again in 2011 and this year. The form must be completed and submitted to the county auditor's office at least once prior to a Jan. 1, 2013 deadline. "There are some people who have filled them out several times, submitting a form each year. They did not need to do that ... it only needs to be submitted once," said Vigo County Auditor Tim Seprodi.. The forms are required under a state measure aimed at reducing duplicate homestead property tax deductions."The homestead deduction gives a qualifying individual or couple a substantial property tax benefit by lowering their property tax obligation," Brian Bailey, commissioner of the Indiana Department of Local Government Finance, said in a written statement. "When individuals who do not qualify receive this benefit, it costs other taxpayers more."In 2010, about 3,400 parcels in Vigo County were "questionable" as double-dipping on homestead deductions for property taxes following a review from SRI Inc., an Indianapolis firm hired to research property parcels and tax payments back to 2007. The county since has collected about \$380,000 in back taxes/penalties from duplicate homestead deductions, Seprodi said. A homestead deduction allows homeowners who use a property as a primary residence to qualify for a reduction of the lesser of 60 percent of the property's assessed value or \$45,000, plus up to an additional 35 percent of the remaining assessed value through the supplemental homestead deduction, according to the Department of Local Government Finance. Of the more than 60,000 property parcels in Vigo County, Seprodi estimated about 40,000 parcels have been designated for the deduction from submitted forms. "Presently, we are trying to get all of that information into the [county computer] system," he said. By the end of January, Seprodi said his office will send out a letter to taxpayers receiving the homestead deduction who have not filed the homestead verification form on or before Dec. 31."We have to notify taxpayers if they have not complied, we will remove their deduction. They will have two weeks [after that notification] to come in [to the auditor's office] to make sure they comply," Seprodi said. Taxpayers whose taxes are paid by a mortgage company or bank should have received the pink notifications, along with the bank, Seprodi said. Any such taxpayer who has not received a notification should contact his office at 812-462-3361. "Once we check it, we take care of it and it is not a problem," Seprodi said. "If a mistake is made like that, it can be corrected" even after the deadline, the auditor said. "The problem that arises is when a taxpayer gets a notice, does nothing, just lets it ride, and because the taxpayer didn't act, the deduction will be removed."Additional information about the homestead deduction is available on the Indiana Department of Local Government Finance's website at www.in.gov/dlgf/8455.htm.

Today, I have more questions than answers, like, who in the administration is marketing these? Who is empowered to negotiate them? Based on the response from Leslie....it looks pretty anemic compared to the number of tax exempt properties in Terre Haute. I would have thought this to be a few million \$\$ per year. What is the basis for determining the fee (i.e. is there a defined policy?) Is there any way to force these? All good questions, now to find some answers. According to the current City Council agenda for December, it looks like the council may need to be involved — Appropriation # 25 attached.

What is going on at the Vigo County Library?

The New carpet and flooring are being installed. Several areas that were carpeted are now hardwood which should minimize maintenance and provide for longer life. Looking good! The search for a new director is moving ahead in good order and is narrowing from 24 to 8 and now 3 candidates. Pat Carney presented the 2013 Health Insurance package proposal at the Board Meeting. Would you believe the increase in premiums for 2013 is 0%. I have never heard of that.

Based on an assumption that due to the Tax Caps and changes in deductions, property tax revenue has declined within the city over the last 4 years. We selected 100 homes at random in Terre Haute City for non rental properties that were subject to the 1% tax cap.

While we know the reduced revenue occurred in the aggregate, we were looking to see if there were trends related to how / where it occurred.

Conclusion from the Data:

There <u>was</u> a significant decline in tax dollars on properties with assessed values of \$85,000 and above. There was no observable reduction in taxes on properties under \$85,000 assessed value.
