

## Minutes of the THMGC General Membership meeting held on 18<sup>th</sup> August 2021.

The following are the Minutes of the Temeku Hills Men's Golf Club General Membership meeting held on Wednesday 18<sup>th</sup> August 2021.

**The President** John Hamby declared the meeting open at 0745. The following Board members were in attendance: Louis Lanni, Lee Wortman, Jim Dent, Ron Frederick, Ron Vaught, Bill Ryan, John Kupka, Bob Dubay, Richard McAlpine and 32 members. Don Wadsworth was absent.

**The Minutes** of the General Membership meeting held on 26<sup>th</sup> May 2021 were approved (Frederick/Kupka).

**The Financial report** was presented by the President. As at 30<sup>th</sup> July the bank balance was \$11,058.73. Total expenditure was \$1,044.68 (KP supplement \$155, complimentary entry fee \$645.00). Hole-in-one insurance \$295.00. SCGA membership income \$614.00. The report was approved (Saari/Dent).

**The Tournament Chairman** B Dubay advised the next tournament would be a 6x6x6 two man team, pick your own partner to be held on 22<sup>nd</sup> September 2021.

**The Membership report** was supplied by R Vaught as follows: As of June 30, 2021, Temeku Hills Men's Golf Club Memberships are as follows:

**The Scrip report** was submitted by L Lanni who advised as of August 1, 2021, the scrip checking account has a balance of \$10373.51 with outstanding checks of \$1767.50. Uncashed scrip totals \$10,362.00. This leaves a positive account-to-uncashed scrip difference of \$11.51.

The difference is attributable to a \$10.00 underpayment to The Legends which they refused when I tried to make good (the underpayment was the result of The Legends miscounting their held scrip); \$0.51 interest earned on the scrip account and a \$1.00 prize adjustment that occurred on 11/18/2020. It should be noted that the 2020 (Red) scrip will expire on 31 December 2021.

**The Handicap Chairman** J Kupka requested all members to post their scores as soon as possible after play of the first round of the Club Championships.

**The Rules Chairman** L Wortman referred to the current state of the bunkers and advised members to play the ball as it lies if a rake is present in a bunker. If there is no rake, then lift, clean and place the ball in the bunker. He referred to the bunker in front of the 10<sup>th</sup> green which is in poor state of repair. He proposed a ball in this bunker should be lifted, cleaned and placed outside the bunker. This was agreed.

**Old Business.** The President reminded members that there were several positions available on the 2022 Board and requested any members interested in joining the Board to contact J Dent.

**Other business.** A raffle for a \$50 gift voucher sponsored by Air Temperature Control Specialists was held before play of the Club Championships. The winner of the raffle was Neil Miller.

The next General Membership meeting will be held on Wednesday October 27<sup>th</sup> when elections for the 2022 Board will be held.

There being no further business the President declared the meeting closed at 0755.
