

TEEN GIRLS NETWORKING CIC PRIVACY POLICY 2020/21

We take the protection of your private information very seriously. This Statement of Privacy applies to www.teengirlsnetworking.org.uk and governs how data can be collected and used.

Collection of your Personal Information

Teen Girls Networking website may collect personally identifiable information, such as your:

Name, Contact Number (Both parent/carer and Club user)

Email Address (Both parent/carer and Club user)

Teen Girls Networking website may also collect demographic information which will remain anonymous and cannot be used to identify you, such as your:

Postal Address

Age, Cultural ethnicity

We may gather additional personal or non-personal information in the future.

Please keep in mind that if you directly disclose personally identifiable information or personal sensitive data through Teen Girls Networking public message boards, this information may be collected and used by others. Teen Girls Networking cannot be held accountable for this.

Teen Girls Networking recognises that there may be occasions where you decide to link to other Social Media sites from Teen Girls Networking website. In doing this Teen Girls Networking is not responsible for the privacy statements or other content on those sites outside of Teen Girls Networking website.

Use of your Personal Information

Teen Girls Networking may use your personally identifiable information collected from Teen Girls Networking website to inform you of other products or services available from Teen Girls Networking and its affiliates. Teen Girls Networking may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.
