Councilperson Conklin stated that he only repeated what the Budget Officer said "We were missing \$100,000.00 last year and \$31,000.00 this year". David Miller stated it was Brandon's fault we were audited and cost the town \$14,000.00. David Miller then asked did he know the money was found before he submitted his article in the paper to which Councilperson Conklin replied "I still don't know if it was actually found". David Miller then stated that the Town should consider making the Highway Superintendent position an Appointed position vs an Elected position. Arica Harris stated this isn't just against our current Highway Superintendent, this harassment has been going on with the previous Highway Superintendents, David Harris and Dan Parrillo, Jr. Laura Souders concerned that Bob Ames said he had spoken with Brandon before submitting his article. Brandon replied he didn't think he has spoken to Bob, but later corrected himself stating Bob wouldn't lie, and that he had spoken with him. Jeff BeGell added that the only thing in Bob Ames' article that wasn't correct was the fact that there are 32 not 33 townships.
