



# RELEASE AND WAIVER OF LIABILITY

In consideration of the Registered Guest, **their family and any other minors or campers in their care, their invitees and/or their guests** being permitted to use the Durham Bridge RV Resort campground, property and facilities, which include but are not limited to its outdoor swimming pool (temporarily closed), Clubhouse (temporarily closed), shower/washroom facility (temporarily closed) and river access (hereinafter collectively referred to as "the Campground"), the undersigned Registered Guest hereby freely, willfully and without duress executes this Release and Waiver of Liability under the following terms:

## WAIVER & RELEASE

The Registered Guest does hereby release and forever discharge and hold harmless the Resort and its successors and assigns from any and all liability and claims, demands, right of action, or actions, of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from this contractual relationship. The Registered Guest understands and acknowledges that the execution of this Release discharges and will discharge the Resort from any liability or claim that the Registered Guest, their family and any other minors or campers in their care, their invitees and/or their guests may have against the Resort with respect to any bodily injuries, personal injuries, illnesses, death, or property damage which may arise during the Registered Guest's stay at the Campground, including, without limiting the generality of the foregoing, accidents or injuries that may result on, in or from an addition being made, assembled or brought onto the property of the Campground by the Registered Guest.

The Registered Guest further agrees to hold harmless and indemnify the Resort from any legal matter, lawsuit or litigation arising from the use of the Campground.

## ASSUMPTION OF RISKS

The Registered Guest recognizes and understands that certain activities at the Resort may be inherently dangerous and hazardous, including but not limited to the following:

- (1) Swimming in the outdoor pool, where there is no lifeguard on duty.
- (2) Weather conditions which may present a danger to campers.
- (3) Activities on or in the Nashwaak River.
- (4) Encounters with wildlife.

The Registered Guest hereby expressly and specifically assumes the risk of injury or harm in these and all other situations and releases and discharges the Resort from all liability for any injury, illness, death, or property damage resulting from the activities of the Registered Guest, their family and any other minors or campers in their care, their invitees and/or their guests at the Resort.

This agreement shall be governed by and interpreted in accordance with the laws of the Province of New Brunswick.

This Release shall be effective and binding on me, all adults listed above and minors listed below, as well as any other minors or campers in their care, their invitees and/or their guests, and our respective heirs, next-of-kin, executors, administrators, assigns and representatives.

The Registered Guest expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the Province of New Brunswick. We agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions hereof, which shall continue to be enforceable.

**I/We have fully informed ourselves of the contents of this Release by reading it before signing.** By signing this Release and Waiver of Liability Agreement I/we assume all responsibility for each member of my party listed on this waiver and any visitors we may have.

## **COVID-19 SAFETY MEASURES:**

**All Registered Campers are required to answer the following active screening questions which are applicable to ALL MEMBERS of the Registered Camper's group and acknowledge/mandate Personal Protective Practices.**

All campers must truthfully answer **NO** to all questions in order to pass screening and can enter the campground.

If any camper must truthfully answer **YES** to **ANY** of the screening questions, or refuses to answer, then screening has been failed & access to campground is denied.

- 1. Does anyone have any TWO of the following symptoms that are not related to a known pre-existing health condition?** Fever, cough (or worsening cough), diarrhea, loss of smell or taste, runny nose, sore throat, muscle pain, headache, fatigue/exhaustion? In children, purple marking on the fingers and toes? **If Yes, return home, self-isolate, call 811 and get tested for Covid-19**
- 2. Has anyone been advised by:**  
Public Health, health-care provider or peace officer that you are currently required to self-isolate?
- 3. Is anyone waiting for a Covid-19 test result?**
- 4. Has anyone had a Positive test for Covid 19?**

- 5. In the last 14 days** (unless exempt from self-isolation)
  - Has anyone travelled outside of NB?
  - Has any individual in any camper's household returned from outside of NB?
  - Has any individual in any camper's household developed one or more symptoms of Covid-19 as listed in question 1 above?

**Please acknowledge your understanding and agreement to the following Covid-19 Personal Protective Practices. By signing below, you agree to be responsible for educating and ensuring all members of your camping group follow these safety measures:**

- **Physical distance** (2M/6Ft) from other Campers NOT part of your Steady 10/15
- Do not enter another camper's site unless invited & sufficient room to maintain proper & effective physical distancing
- Consider wearing a face mask if **physical distance** can not be maintained where other Campers are NOT part of your Steady 10/15
- Frequent hand washing and regular cleaning/sanitizing of frequently touched surfaces on your RV and item in your campsite is strongly recommended
- Your RV must be equipped with a fully functioning kitchen and bathroom to ensure proper personal hygiene
  - PW1 & PW2 sites will have secure access to their own bathroom facility
    - Bathroom facility will be cleaned/disinfected prior to arrival; campers are responsible for cleaning during their stay
- Parents **MUST** ensure their children follow these safety measures
  - Children will need to be monitored to ensure they are not entering other RV sites without permission
- No visitors, all guests must be registered campers, no exceptions
