## **CLIMATE CHANGE**

The Earth's climate has changed many times since our home planet has been in existence. However, the most pressing environmental issue of the 21st century is global climate change due to increased levels of CO2 and other greenhouse gases (GHGs) in the Earth's atmosphere caused by human activities. The primary causes of these increases are burning of fossil fuels; coal and oil, to support industry and provide energy, and deforestation and the accompanying land use change.

Levels of GHGs have increased at alarming levels. Prior to 1950, these levels have been either at or below 310 parts per million (ppm) for at least 400,000 years. Since 1950, GHG levels have exceeded 310 ppm and in 2016 reached 400 ppm.

Effects of climate change have been underway at least since the 1950's. These include rising temperatures, rising sea levels, warming oceans, shrinking ice sheets, retreating glaciers, extreme weather events, acidification of oceans and decreased snow cover. Global temperatures for November 2016 and for each of the preceding 14 months have been at record highs.

Can anything be done about human-caused climate change? Two approaches are recognized. One is to adapt to changing conditions such as altering agricultural practices to accommodate changing conditions or to move human settlements inland as ocean levels rise. The other is to mitigate climate change via reducing our dependence on fossil fuels by developing alternative energy sources such as wind and solar. In addition, because trees and forests, via photosynthesis, remove carbon from the atmosphere and store it in woody tissue, increasing forest cover and managing the world's forests can reduce levels of GHGs in the atmosphere.

The UN has been proactive in calling attention to global climate change. In 1988, the UN Environmental Program (UNEP) and the World Meteorological Organization (WMO) chartered the International Panel on Climate Change (IPCC). IPCC provides the world with a clear scientific view on climate change and its environmental and socio-economic impacts. Thousands of scientists contribute to the work of the IPCC, which issues periodic assessments of the state of knowledge of climate change. The most recent assessment was released in 2013 and 2014. In addition, in 1992 the UN Framework Convention on Climate Change (UNFCCC) was chartered at the Earth Summit in Rio de Janiero, Brazil. Under this framework, a number of agreements have been developed that commit signatory countries to reduce carbon emissions. The most recent was the Paris Agreement of December 2015. To date, 193 countries have signed this agreement and 115 have ratified it.

Unfortunately not everyone agrees that climate change is real. Representatives of the coal and oil industries, who feel threatened by climate change initiatives, deny that the issue is real. Moreover, a leading US politician has referred to climate change as a "hoax" and could reverse initiatives currently underway to reduce GHGs.

Can the present trend of increasing GHGs in the Earth's atmosphere be reversed? The answer is a qualified "maybe." With increasing levels of human population and increased standards of living in third world countries, resulting in greater demands for food and energy, climate change skeptics and uncertainties associated with development of alternative energy sources, the challenges are many and complex.

# US FUNDING OF THE UN

The events of the past month have made me even more aware of the need for our UNA to exist.

Senators Lindsey Graham and Ted Cruz introduced a bill to completely defund the UN unless it reverses the vote regarding settlements in Palestine. This bill will eliminate the U.S. participation in the UN weakening America's ability to achieve vital economic foreign policy and national security goals. Because the US provides significant funding to the UN's humanitarian assistance network, vital programs will be slashed, including the World Food Program, UNICEF, UNHCR, and UN peacekeeping missions, among many others. In addition to the above, President Trump is establishing a committee to review *U.S. Support for the UN* and other international organizations. The end goal appears to be reducing voluntary contributions to international organizations by 40%. That would include family planning programs and "mandated US contributions" (i.e., the legal obligation of membership).

Something to keep in mind when we write our officials: One percent of the federal budget goes toward both bilateral and multilateral foreign aid--an exceedingly small portion of the federal budget.

The US does pay the largest share (22%) of the UN *Regular Budget*. Dues are based on a formula taking into account the size of a country's economy and its per capita income. Based on those criteria, the US is actually underpaying. *It is the only developed country not subject to the normal formula*. Other countries are larger donors to individual agencies and programs. (For example, Japan contributes \$355 million to UN Development Program; the US contributes \$266 million). Other donor nations find US complaints of "burdensome" contributions difficult to swallow.

Being in good financial standing facilitates US diplomacy at the UN. Top donors tend to get seats on UN governing bodies. If we are not there, cooperation in fighting terrorism will be much more difficult. Rising powers such as China can step in where the US has ceded influence. #### 2016 ANNUAL MEETING MINUTES:

#### 12TH ANNUAL MEETING NORTHERN COLORADO CHAPTER OF THE UNITED NATIONS ASSOCIATION 20 FEBRUARY 2016 PLYMOUTH CONGREGATIONAL CHURCH, FORT COLLINS

President Eleanor Dwight called the 12th annual meeting to order at 11:05. A quorum (37) was present. Eleanor welcomed everyone and explained that the minutes of the 11th Annual Meeting, 2015 Treasurer's Report, 2015 Annual Committee Reports, and the 2016 Slate of Officers and Board Members had been posted for review in the UNA NoCO Newsletter on 5 February and copies of all reports were available for review on each table.

**11th Annual Meeting Minutes.** Eleanor explained our practice of having two volunteers review the minutes after the meeting for corrections rather than wait until the next annual meeting. Last year's volunteers were Bill Ciesla and Eleanor Dwight. Eleanor asked if there was any discussion on the minutes. There was none. It was moved, seconded and passed to accept the 11th Annual Meeting minutes as written. Mary Kay Gardner and Eleanor Dwight volunteered to review the minutes this year.

**Treasurer's Report.** Treasurer Don Heyse walked us through the 2015 Treasurer's Report and 2016 Proposed Budget, copies of which were available on the tables. The bank balance as of 31 December, 2015 was \$2201.22. Don drew our attention to the negative balance in the Final Essay Fund. The Essay and Art contests are funded solely by individual donations. It has been our practice to solicit donations at the Annual Meeting (a donation basket is located on the sign-in table). Don explained that thus far we have not needed to 'dip into' our regular account to supplement the Essay Fund but it was a possibility.

Heidi Nash Cross, who is catering our luncheon, came forward and donated her reimbursement to the Essay Fund. She challenged all attendees to 'match' her donation and add a few dollars to the donation basket on the sign-in table.

Don explained a new item on the budget: Member Travel Subsidy. Attending the National UNA Convention is beneficial to both the individual attending and to our organization. The travel subsidy is intended to help defray costs of one member every other year. Beginning in 2015, \$250 has been budgeted each year for this trip with the understanding that every other year (even years) someone will receive \$500 to go to the convention. Eleanor asked that anyone wishing to apply for this stipend should let her know.

With no other questions or comments on the proposed budget, it was moved and seconded and passed to accept the 2015 Treasurer's Report and 2016 Proposed Budget.

**Nominating Committee Report.** The Nominating Committee consisted of Bob Jeffrey, Eleanor Dwight, and Marty Tharp. Eleanor reported on the committee's work and Bob Jeffrey announced the Nominating Committee's slate and asked if there were any nominations from the floor. There were none. It was moved, seconded and passed to accept the Nominating Committee's Report. Eleanor then asked for a vote on the Slate. The Slate passed unanimously.

**U.N. in the News.** Our custom to begin every meeting with a brief discussion of U.N. in the news. Eleanor apologized for forgetting to do this earlier and asked if anyone had any news to report.

Bill Ciesla reported that the U.N. Secretary General's term ends this year and four candidates have been announced: Irina Bokova current UNESCO Director General, from Bulgaria; Vesna Pusic, Deputy Speaker of Croatian Parliament; Srgjan Kerim, Former President of U.N. General Assembly, from Macedonia; Danilo Turk, Former President of Slovenia; Igor Luksix, Foreign Minister of Montenegro; Natalia Gherman, Former Minister of

Foreign Affairs and European Integration of Moldova. This is the first time in their history that women have been nominated.

Margaret Smith reported that UNHCR is the 2016 winner of Arab American Institute's Kahlil Gibran Spirit of Humanity Award for their work with Syrian refugees. She reminded us that UNHCR is a very worthy organization and could still use donations for Syria.

**Membership Committee Report.** Eleanor Dwight serves as Membership Chair. She reported that we have approximately 80 members. This is down from 2014; however, part of the reduction is because many of our GenUN student members did not renew their membership. She encourages each of us take a few of the UNA membership flyers and invite a friend to one of our programs. The National UNA has raised dues for the first time in many years. Regular membership is now \$50 a year. She reminds us that half of this comes back to our own chapter. Eleanor would like to have more people helping with Membership. Pat Ciesla has done tremendous work, particularly on the technical side, especially with the Membership Booklets, but it would be great to have additional helpers. Please see Eleanor if you would like to volunteer.

Advocacy Committee Report. Eleanor gave the report for Chairman Ed Archer, who is out of the country. Other members of the committee are Bill Ciesla and Daniel Owen. Eleanor reported that the committee collaborated with Denver and Boulder UNA Chapters in lobbying our representatives to support funding for UN Peacekeeping, support USA payment of UN dues, and encourage USA approval of the climate change resolutions in Paris meeting on Climate Change. The committee also sent letters to our Congresspersons thanking them for voting for full funding of the UN and the UN Peacekeepers and signed a letter to President Obama along with 30 other organizations asking him to tackle the root causes of the Syrian crisis. Eleanor explained that the committee also has written letters to the editor, but they don't ever seem to get published. She drew attention to one letter that was published, "Ordinary People Key to Sustainable World Peace," written by UNA member Bill Timpson. Copies of it are available on each table.

**Outreach Committee Report.** Chair Elissa Tivona, who is also pleased to serve as Vice President, explained that the Outreach Committee is the best 'job' to have. Traditionally, the committee is responsible for selecting the International Humanitarian Award and organizing the IHA program. Although we used to hold the IHA program in the spring, last year we used it as our fall kickoff meeting in September. The 2015 IHA winner was Loveland Rotary Club for their health and dental services to rural villages in and around Tehuacán, Mexico. This year, the committee will focus on Young Humanitarians. Anyone wishing to nominate a person or organization for this award, should see Elissa for an application form.

The committee also worked closely with Department of International Studies at CSU. They conducted a "UN 101" program, moderated by Dick Rush and Eleanor Dwight. Also, they cohosted (with Boulder and Denver UNA chapters) a field trip to the Posner Center in Denver. The Posner Center is home to some 60-odd business and organizations focusing on international development, with work encompassing agriculture, community development, education, energy, health, infrastructure, microfinance, and various other fields. The attendees, students and UNA members, were so enthusiastic that another trip is planned for the near future. Elissa asked that anyone interested in helping on the Outreach Committee contact her.

**Education Committee Report.** Dick Rush, Jane Thompson, and Bob Jeffrey each lead one of the student contest subcommittees: Dick leads the elementary school art contest subcommittee; Jane leads the middle school writing contest subcommittee, and Bob heads up the high school writing contest subcommittee. Dick reported for the group. In 2015, there were 152 entries in the elementary art contest and 72 entries for the middle school writing contest. When you consider the number of students, teachers, families and friends involved, then it seems that the Education Committee is fulfilling our mission to education people about the UN. During a regular year, our three contests require \$570 for awards. We have three options: to continue to count on the good will of our members to donate to the Essay Fund, to roll the Essay Fund into the General Fund, or the cancel some of the contests. The committee will be bringing this to the Board at their spring meeting.

**Indigenous Concerns Committee Report.** Eleanor noted that our chapter is one of very few to have an Indigenous Concerns Committee. Chair Christinia Eala reported that the committee has been actively supporting Tiyospaye Winyan Maka, a non-profit organization whose mission is to create housing on the Pine Ridge Reservation.

In the fall of 2014 Dan Fink, Owner/Director of Buckville Energy conducted an alternative energy workshop to build a solar array panel for the Fast Horse Homestead in Wounded Knee. In May, UNA members Christinia Eala, Elissa Tivona and Glenn Blanc; a 9-person crew from Engineers Without Borders at Colorado State University (EWB/CSU); Dennis Warren, a 25-year supporter of Tiyospaye; and two volunteers from the Colorado Springs area, traveled to Wounded Knee to build the foundation for the battery house for the solar array panel and install

a 350-gallon water tank. Additional plans are to construct an underground greenhouse, reinforce the outdoor kitchen, construct additional outhouses and a solar shower, and maintain the campground.

In August, members of the committee traveled to Green Grass on the Cheyenne River Reservation to support the Sundance Ceremonial. UNA member Susan Solick donated a supply of medical supplies and food, which were received with gratitude by the medic and the chief cook who cooks for at least 600 people every year.

The committee continues to monitor and support a number of indigenous initiatives, such as the Cheyenne River Mni Water Project; Earth Tipi at Manderson, SD; Four Winds American Indian Council, Black Mesa Caravan, CO; and, Earth Guardians.

**New Business.** Eleanor announced that we are losing two of our very best, most active couples on the Board: Margaret and Paul Smith, who had been on the Board since the beginning—Margaret, serving as first President and the Membership Chair for many years; and Paul, serving as secretary. Also, Bill and Pat Ciesla, who have provided much support to the Advocacy and Membership committees. Although they will no longer be serving on the Board, they intend to continue participating in UNA activities. Eleanor presented each with a memento in appreciation for their many years of service.

Eleanor then took a moment to discuss the status of our chapter. She was pleased to report that our chapter is healthy and viable. We have sufficient funds to conduct our programs and we have fulfilled our charge as advocate for the UN. Our priority now is to bring in new members.

Last year, we had a UNICEF Help Syrian Children Campaign fundraising dinner at our Annual Meeting. We received quite a bit of coverage on that, as well as raising over \$3,000. For UNICEF. Our International Humanitarian Award and our student art and writing contests have enabled us to develop good connections with educators throughout the community. However, we have not been able to get a Model UN going. Jane Thompson commented that she thought Tod Huckaby may be doing a Model UN. She will check with him and let us know.

Eleanor urged members to sign up for the UN Wire [un\_wire@smartbrief.com], a daily e-mail report about what is world, and Dawn's Digest happening in the the blog by Mark Goldberg [https://www.globalcitizen.org/en/partners/dawns-digest/]. Mr. Goldberg was our featured speaker at our 2013 International Human Rights Program. Eleanor also encouraged everyone to watch their e-mail for announcements of the monthly National UNA Conference Calls, which involve experts and top UNA personnel and provide opportunities for listeners to ask questions and enter the discussion.

Susan Solick announced that the Colorado ACLU has reorganized and disbanded its local chapters. So the Northern Colorado Chapter of ACLU, who have long been our partners for the December International Human Rights Program, is no more. The State ACLU will still maintain its Speakers Bureau. They have a number of excellent speakers who can be provided at no charge. For information, see http://aclu-co.org/in-the-community/speakers-bureau/

Eleanor asked if there were any additional comments or announcements. There being none, the meeting was adjourned. Members and guests then enjoyed a lovely buffet luncheon, courtesy of UNA member Heidi Cross and a number of other volunteers, and listened to an enlightening presentation on "The United Nations and Peace and Security in a Troubled World," by Ed Elmendorf, former President and Chief Executive of UNA/USA.

At the beginning of the year, Chairman Ed Archer attended an advocacy strategy meeting with other area chapters. He resigned from the chairmanship last spring. UNA NoCO member, Loretta Scott, has developed a Proclamation Supporting CEDAW to the City of Greeley in partnership with Zonta club and BPW. They are currently refining the language in it.

The 2016 winner was Meagan Cain, a graduate student in the Colorado School of Public Health at the UNC Community Health Education Master of Public Health (MPH) program in Greeley. She was nominated for her work establishing the *Girls Moving Mountains* program in Nepal; organizing a fund raising to supply textbooks and school uniforms for Igodivaha Primary School in Njombe, Tanzania, and her work as volunteer health educator at the Global Refugee Center in Greeley.

The Outreach Committee organized the presentation of the 2016 International Humanitarian Award to Meagan Cain and featured an impressive program of her international humanitarian work in September.
