_____ **Morning Care (7:30am to 8:30am)**

Parents may park and walk students to the school door. If you arrive after 8:25am, you must stay in the already in progress school carpool line.

_____ **Mini-Aftercare (pickup by 4:00pm)**

Parents must park and come sign student out in the front office. If you arrive while a dismissal care pool is going on, you must stay in the carpool lane and advise the carpool attendants who you are picking up and they will be called out.

_____ **Full Aftercare (pickup by 6:00pm)**

Parents must park and come sign student out in the front office. If you arrive while a dismissal care pool is going on, you must stay in the carpool lane and advise the carpool attendants who you are picking up and they will be called out.

Morning/after care charges are to be paid in advance. Failure to pay on time will result in withdrawal from the program. There are no partial payments or prorations for the monthly cycle. No child will be allowed to begin in a service period if account is past due and payment has not been made.

If the student is enrolled in mini-after care are not picked up by **4:00pm**, a late fee of \$15.00 will be charged. After the 2nd late pickup in a one-month cycle, the student will be enrolled in full care and charged accordingly.

For full aftercare students not picked by 6:00pm, a late fee of \$15.00 will be applied plus \$1.00 per minute past 6:15pm will be applied. After three late pickups in a one-month cycle, the student may be expelled from aftercare.

If there is an outstanding balance with Paramount Youth the student will not be enrolled in any Paramount Youth program, including before and after care.
