October 2022 Updates for Advisors:

For the start of the school year, we have been blessed with adding a few more chapters to our list. Last school year we had 16 registered chapters. This year as of this date we have 22 registered chapters. We are excited to see the growth that has been happening and this is all thanks to our student officer team!

Membership registration continues to happen as of this date we have **8** Registered Chapters and **167** registered members and advisors. I have no doubt that this number will continue to grow. I will be reaching out to schools during the month of October to find out which clubs are co-curricular. **Please continue to register members.** Our next deadline is November 30th.

The Washington Commanders event is scheduled for Thursday, October 13th. It does cost \$45 to attend, but in return, members who do attend will get a ticket to the Washington Commanders game on November 27th against the Atlanta Falcons. Upgraded tickets are available for \$75-\$115 per ticket. Please contact Jake Supran at Jake.Supran@commanders.com no later than October 7th to reserve your space.

Power Trip is being held in Alexandria VA November 11-13th. This is a great opportunity for us since it is so close. And a great opportunity for all of our new clubs and advisors to get a taste for what DECA is all about. Clubs within a 50 mile radius of the event location can commute. Which means they do not need to stay at the hotel. The \$135 per person registration costs includes all three days, but many clubs are planning to attend just on Saturday the 12th, due to all of the courses, workshops and a competition for students happening on that day. The advisor workshops are also available on that date. If a club does decide to stay all three days, hotel rooms are \$209-\$227 respectively per night. I will be reaching out to clubs within the next week to see who might be attending. Either for the day or the whole weekend. Registration closes October 12th.

Regionals are right around the corner and since we only have a Region 1 VP, Region 1 will be holding theirs at Richard Montgomery HS in Rockville on Saturday December 17th. We will start registration at 8am and the event will conclude at 1pm. This will be the first in person event since January of 2020. This event is practice and is not a precursor to qualifying for states. It gives new members and returners the opportunity to practice their chosen event. Only Individual and Team events are included and members will take an online test prior to the event with their advisors as proctors. A letter will be sent to all Region 1 Schools by October 15th with Registration information and sign ups. Cost per participant is \$20 per person. We will have snacks available, but attendees are asked to bring their own lunch or money to purchase lunch at the conclusion of the event. We ask that all advisors attend or if unable to attend that a school representative familiar with your club attend in your place. You may be asked to judge and will be needed to help with your student group.

SCDC 2023 will be held at the Delta Marriott Hunt Valley 245 Shawan Road, Hunt Valley, Maryland, USA, 21031 Tel: +1 410-785-7000. Date is Friday February 24th, 2023 starting at 7:30 am until 8:30 pm. It is an extremely long day, but we are looking at options to book rooms if your group desires to stay the night on the 24th. Pricing is still being worked out, but will range between \$135-\$145 per person. We are asking all clubs to ask for judges. Please share [this link](#) with your parents and community members. More information will come in our Fall update.

ICDC 2023: The convention center is located across the road from our hotel. There is a pedestrian bridge that connects outside our hotel and the convention center on the backside. The hotel rooms come with two queen beds or one king bed. And the rate without tax or fee is \$149 per night. As of now, please plan on the cost per room of \$169.12. This is 1-4 people per room. And I would encourage you to start filling out school required paperwork as soon as possible. The hotel ([Tru by Hilton Orlando Convention Center Area](#), 6461 Westwood Boulevard Orlando, Florida, 32821, USA) is relatively new and we do have meeting space available inside the hotel. There is also free breakfast and we will be sharing with Nevada. The competition venue is the Orange County Convention Center. It is a very large space and every event will be contained in that space from opening ceremonies to closing ceremonies. There are also on site eating locations for advisors and members. I have secured a travel agent that will provide groups the opportunity to book with them for an additional fee of \$50 per person. The travel agent will arrange flights and hotel transfers with a stop at a local grocery store on the way to the hotel. The travel agent will need a basic head count from advisors by the end of October in

order to start securing flights for ICDC (April 22-26). Please contact the travel agent directly: [Peter Scocca](#) to schedule flights and transportation and reserve your space. It is better to go over the amount to secure the correct number of seats, but I would encourage you to contact him no later than the end of October if you would like to use his services. We have worked with him in the past, so he knows what our requirements are and he has also worked with FBLA.

MD DECA ADVISOR RESPONSIBILITIES

The purpose of this list is to provide Maryland DECA advisors a guideline to their roles and responsibilities for advising their clubs. Below you will find a list of items that every advisor must agree to in order to sponsor a MD DECA club.

1. The advisor is the point of contact for DECA and the school. Which means they will need to fill out and complete required paperwork and DECA paperwork. Each school/county has its own set of required paperwork. Please consult your individual school for this paperwork. (There is more for MCPS, but it is very easy to find). A list below will help get you started for field trips.
2. The advisor should plan on attending the Regional, State and International Competition (should anyone at your school qualify). This is an absolute must, but payment for travel is covered by members of your club. Regionals are at RMHS next year and States (SCDC) are in Baltimore for one day. ICDC is in Orlando for 4-5 days in April. All expenses are the responsibility of each individual club. If the advisor cannot attend, a staff member from your school must be in their place. You may have a parent volunteer or another staff member as an additional chaperone.
3. For meetings during the year, advisors should provide the space, but the club is entirely student led, except when an adult is needed as outlined above.
4. Advisors are also responsible for depositing funds/setting up OSP as per guidelines, or organizing collecting and depositing funds per your school's guidelines.

Each county has its own paperwork to submit in order to have field trips approved. Please speak with your school's Business Manager/Finance Manager to arrange to have your paperwork submitted and approved items completed before registration for events close.

Maryland DECA is not responsible for school's approval. It is up to each advisor to submit proper paperwork for your school. Below is a list of locations on each district's website to obtain necessary guidelines/paperwork to submit for field trip approval. This may not be a complete list of forms needed, please check with your individual school's for a complete list. Private/Charter schools may have their own set of paperwork, which you should contact your school's representative to fill out and submit.
