Tractor log

MC – wants complete log of tractor use and where it has been/ fuel/ etc.

He presented a draft copy of a proposed log of use sheet to be kept at GR with the Tractor. It was then also proposed that it should also include a log of the maintenance, service and vehicle check list which would be completed each time before it was used.

RM - Says the £16000 shed not up to standard

AJ suggested to get independent quote

DF says building inspector to come out and look. He originally wanted old shop converted to shed and new shop built.

PC- to get shed inspected . Proposed MC seconded SW - unanimous vote to go ahead with arranging a building inspector to view the tractor shed.

Explaination about going to BR

MC - apologised for coming up to fix Alan Martins tap. He did not mean for it to appear to take over or to cause problems.

Keys

Keys for shop and Tractor shed

MC – proposed that the shop and the Tractor shed at GR have two padlocks so that so that two people have to open up to get into the store or to take deliveries ie) padlock A and padlock B. This is to ensure no accusations of stock being unaccounted for and also for health and safety reasons.

AJ - says does not think it will work.

Compost had gone missing in the past.

SW - How often stock check - RJ - previously at year end, but has been changed to monthly.

MC - Proposed PC- seconded 2A & 2B padlocks and keys for the shop and tractor shed, so that 4 people have keys. Voted - 5 for 1 against 2 Abstain

RJ and DF to buy 2 locks each

Keys for fields

MC – Proposed that all committee members who want to, may have keys for all fields. This is so that if needed in an emergency someone from the committee could get to the field quickly.

RJ – wants that to go to AGM agenda.

RM – does not want a key. That's what steward is for.

MC – said that it should not to go to AGM prop 5 against,2 for, 1 abstain

MC – proposed PS – seconded. Voting was 5 for, 2 abstain, 1 against

DF – to organise spare keys for WR.

RJ - to organise BR and HR keys.

MC and PC and PS want the additional gate keys

PC - suggested security padlocks for field gates - bring to next agenda

SW - Alarm CCTV to add to next agenda

Ride on mover for DF

MC proposed PC seconded that we buy a 2nd hand metal Haeta Briggs and Stratton mower @ £1000. Voted - 6 for 2 abstain

RJ – to speak to insurance broker regarding the stolen ride on mower from HR. £150 excess.

RJ- says there is not as much grass to cut as at HR 50 thousand sq. ft grass or BR has 47.5 thousand sq ft.

AJ – says BR done by hand 3hrs every week

DF – says uses hand mower for part of the field, but leaves the rest as there is too much to do with a hand mower.

Products for the shop

PC – members to be able to order plant plugs from Brittons through the Society, similar to how we put in potato orders.

PC proposed MC seconded. Voted unanimous ves.

RJ - to find out prices from Brittons

SM – suggested source inexpensive tools to sell in the shop

MC - find out if Stable hire will give us discounted hire

Hedge trimmer BR

RJ - Says is 14yrs old, head needs replacing (MC will look to repair old one too)

£229 to replace head

RJ proposed, Voted - Unanimous go ahead and buy new head.
