2. Each Line on this report represents a BUDGET GROUP. All Treasury Report SOURCES and USES of funds transactions are summarized into these groups.
3. For MAJOR fundraising with a P\&L, both the Receipts and Disbursements related to the fund raising activity are NETTED together into the one line.
4. For smaller fundraising involving Member donations, both the Receipts and Disbursements related to the fund raising activity are shown seperately as both a S\&U.
