Resolution No. 11-3-2014: "FAIR HOUSING RESOLUTION, LET IT BE KNOWN TO ALL PERSONS of the City of Connellsville that discrimination in the sale, rental, leasing, financing of housing or land to be used for construction of housing, or in the provision of brokerage services because of race, color, religion, ancestry, sex, national origin, handicap or disability is prohibited by Title VIII of the Civil Rights Act of 1968 (Federal Fair Housing Law) and the Pennsylvania Human Act. It is the policy of the City of Connellsville to implement programs to ensure equal opportunity in housing for all persons regardless of race, color, religion, ancestry, sex, national origin, handicap or disability, or familial status (families with children)."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmen Geyer, Zolbrod, Ritch and Karpiak and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 11-4-2014: "To accept the resignation of Judy A. Keller, City Treasurer/Tax Collector, effective December 31, 2014."

Resolution No. 11-7-2014: "Be it resolved by the City Council of the City of Connellsville as follows:

WHEREAS, under Title I of the Housing and Community Development Act of 1974, as amended, the Secretary of Housing and Urban Development is authorized to extend financial assistance to Communities for activities which will benefit low and moderate income families, aid in the elimination or prevention of slums or urban blight or other urgent community needs; and

WHEREAS, the Pennsylvania Department of Community and Economic Development (DCED) has invited the City to submit an application in the amount of \$ 288,311 for financial assistance under its Fiscal Year 2014 Community Development Block Grant Program; and

WHEREAS, the City has met all the citizens participation requirements relative to the Community Development Block Grant Program submission; and

WHEREAS, the City has prepared a Three Year Plan and Statement of Objectives as required by DCED; and

WHEREAS, the City has prepared an application for Financial Assistance under the 2014 Community Development Block Grant Program, said application having been duly reviewed and considered by the Council of the City of Connellsville.

- That the Community Development Block Grant Program Application dated November 2014 is hereby in all respects approved. The City Clerk is hereby directed to file a copy of said program and application with the minutes of this meeting.
- That it is cognizant of the conditions that are imposed in the undertaking and carrying out of community development activities with Federal/State financial assistance under Title I, including those under Title VI relating to the prohibition of discrimination because of race, color, creed, or national origin and other implementation of the program.
- 3. That the Mayor, on behalf of Council, is authorized to file an Application for Financial Assistance to carry out the Community Development Block Grant Program and act as the authorized representative for the City.
- 4. That the Mayor, on behalf of the City Council is hereby authorized to provide such assurance and/or certification as may be required by the Housing and Community Development Act of 1974, as amended, and any supplemental or revised data which DCED may request in connection with its review of the application and including any revisions necessary to bring the application into conformity with DCED's final grant for the City."

Tom Currey, Health/Code/Zoning Officer was called to the podium to explain what is going on with the demolition in town. He stated the demolition permit is from Fayette County and is good

for one year. He noted there is a hole in the sidewalk that is about a foot and a half deep but will be filled by the parade.

Resolution No. 11-14-2014: "To execute the Board of Health's order to abate the public nuisance by demolition the following property: 109 Trader Avenue, Connellsville, PA 15425, and to submit the aforementioned property to the Redevelopment Authority for demolition, funds taken from the Community Development Block Grant Monies."

Tom Currey stated these properties have been unfit for human habitation for years.

Resolution No. 11-15-2014: "To execute the Board of Health's order to abate the public nuisance by demolition the following property: 114 Gallatin Avenue, Connellsville, PA 15425, and to submit the aforementioned property to the Redevelopment Authority for demolition, funds taken from Community Development Block Grant Monies."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmen Geyer, Zolbrod, Ritch and Karpiak and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 11-16-2014: "To execute the Board of Health's order to abate the public nuisance by demolition the following property: 256 East Fairview Avenue, Connellsville, PA 15425, and to submit the aforementioned property to the Redevelopment Authority for demolition, funds taken from Community Development Block Grant Monies."

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmen Geyer, Zolbrod, Ritch and Karpiak and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.

Resolution No. 11-17-2014: "To accept the resignation of Susan Joy Lewis from the Board of Health, effective immediately."

Resolution No. 11-19-2014: "To introduce Bill No. 6, Ordinance No.1514: An Ordinance of the City of Connellsville adopting the 2015 edition of the International Property Maintenance Code,

regulating and governing the conditions and maintenance of all property, buildings and structures; by providing the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary, and for occupation and use; and the condemnation of buildings and structures unfit for human occupancy and use, and the demolition of such existing structures in the City of Connellsville; providing for the issuance of permits and collection of fees therefore; providing penalties for the violation thereof and repealing Ordinance No. 1483 of the City of Connellsville and all other ordinances or parts of laws in conflict therewith."

Karpiak questioned what has changed with the IPM Code.

Currey answered the City will save a lot of money on postage. He noted that we now have to send a Certified Letter as the first formal notice of violation. Currey stated if the City adopts this ordinance, he will be able to post a letter on their property and not spend postage on Certified Mail.

A vote upon the adoption of the resolution resulted as follows: Affirmative were Councilmen Geyer, Zolbrod, Ritch and Karpiak and Mayor Lincoln. The majority of the votes being affirmative, the resolution was adopted.
