### **MINUTES**

## **CODE ENFORCEMENT BOARD MEETING**

## November 14, 2016

The Horse Cave Code Enforcement Board met in regular session on Monday, November 14, 2016 at 5:00 PM in the Council Chambers. Present were board members Don Ford, Dean Froedge, Tim Tucker Code Enforcement Officer Ken Russell, and Chairman Leo Schroeder as well as Mayor Randall Curry.

Chairman Schroder declared that a quorum was present and called the meeting to order. The minutes of the September, 2016 meeting were presented. Froedge made a motion to approve, Tucker seconded. Motion carried 4-0.

Chairman Schroder noted that Lacindy Baker, owner of property on Old Dixie Hwy had been invited to attend the Board meeting to discuss her property and was in attendance along with James Roberts, Sr. Russell explained that the property had been in violation of multiple offenses and various notices had been sent to Ms. Baker and that some had been returned due to incorrect addresses. Violations include: dilapidated doublewide mobile home, overgrown grass, bushes, and shrubs, an inoperable vehicle, and an unlicensed travel trailer. Ms. Baker stated the travel trailer had been removed and the car would be removed soon. Ms. Baker agreed the home was uninhabitable and the property was overgrown but stated she did not have the resources to abate the problems by removing the home. After further discussion, the Board agreed to give Ms. Baker 30 days to come to a solution and to report back to the Board at the December, 2016 meeting. Russell is to send a letter to Ms Baker explaining the requirements to put the property into compliance including the current zoning law that will not allow the replacement of the doublewide with anything as a habitable structure but a house built on the property. Per the current zoning ordinance, no mobile or modular homes are allowed in the City Limits of Horse Cave except in a mobile home park.

The code enforcement report for August and September was presented by Code Enforcement Officer Ken Russell. There was no meeting or report in October.
