1. Call meeting to order/roll call

Olmedo explained that Nye County had submitted work requests to install crosswalk signs at the locations in town where there were newly laid crosswalks. She also advised the Board that on November 14 there was a water leak in Round Mountain (Old Town). She thanked Round Mountain Gold Corporation security for contacting the town. Repairs were completed on November 15 and due to shutting down the system, a boil water notice was issued and later removed after testing came back negative for e coli. Road and potholes were repaired in Round Mountain (Old Town). Maintenance is preparing for the Christmas Holiday. A hydrant survey was conducted. Out of 42 hydrants in town, 30 need to be upgraded. Each hydrant will cost approximately \$3,000 apiece. This will be a Capital Outlay Project. Turkey Trot went well. Christmas Parade/Tree Lighting will be December 2. Rescue 1 is out of service due to a cracked windshield. Staff is working with Nevada Rural Water Association to start a GPS project to map locations of water/sewer equipment as well as installation of a leak detection system. Next Town Board meeting is December 14.

Spivey, Jr. asked if there will be a project to move forward with a second floor on the weight room. Olmedo advised the Town will include this as a Capital Outlay Project and suggested to engage the users of the weight room to get their feedback. Faga stated she has received much feedback, all positive. Spivey, Jr. mentioned the weight room users have noticed the equipment taken out of circulation due to damage. And a kudos to the firemen for their training, getting certifications in a short amount of time since we got the new fire chief, that's pretty impressive. Faga added, on top of being a part of the community by posting up, doing a Christmas event, and there is no doubt if there was an opportunity to volunteer, one call and the answer would be yes, if they had the bandwidth to do that. Super impressive and a definite change. Spivey, Jr. added it is very positive and it makes the town look really good.

7. Review and approve invoices for the Town of Round Mountain for November 23, 2021

Faga motioned to approve. Spivey, Jr. seconded the motion; motion passed 3-0. November 23, 2021 invoices approved.
